A BILL

To amend the Internal Revenue Code of 1986 to allow for contributions to the Alzheimer's Research and Caregiving Trust Fund, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

1	SECTION 1. ALZHEIMER'S RESEARCH AND CAREGIVING
2	TRUST FUND.
3	(a) In General.—Subchapter A of chapter 98 of the
4	Internal Revenue Code of 1986 is amended by adding at
5	the end the following new section:
6	"SEC. 9512. ALZHEIMER'S RESEARCH AND CAREGIVING
7	TRUST FUND.
8	"(a) Creation of Trust Fund.—There is estab-
9	lished in the Treasury of the United States a trust fund
10	to be known as the 'Alzheimer's Research and Caregiving
11	Trust Fund' (referred to in this section as the 'Trust
12	Fund'), consisting of such amounts as may be appro-
13	priated or credit to such Trust Fund as provided in this
14	section or section 9602(b).
15	"(b) Transfers to Trust Fund.—There are here-
16	by appropriated to the Trust Fund amounts equivalent to
17	the amounts contributed under section 6097.
18	"(c) Expenditures.—Amounts in the Trust Fund
19	shall be available, without further appropriations, as fol-
20	lows:
21	"(1) Fifty percent to the National Institutes of
22	Health to conduct or support research regarding the
23	treatment or cure of Alzheimer's disease pursuant to
24	the Alzheimer's Disease and Related Dementias Re-

search Act of 1992.

- 1 "(2) Fifty percent to the Administration on
- 2 Aging for education, counseling, respite, and other
- 3 supportive services under the Older Americans Act
- 4 of 1965 for the benefit of individuals with Alz-
- 5 heimer's disease and of their families, caregivers,
- 6 and health care professionals.".
- 7 (b) Clerical Amendment.—The table of sections
- 8 for subchapter A of chapter 98 of such Code is amended
- 9 by adding at the end the following new item:

"Sec. 9512. Alzheimer's Research and Caregiving Trust Fund.".

10 SEC. 2. CONTRIBUTION TO THE ALZHEIMER'S RESEARCH

- 11 AND CAREGIVING TRUST FUND.
- 12 (a) IN GENERAL.—Subchapter A of chapter 61 of the
- 13 Internal Revenue Code of 1986 is amended by adding at
- 14 the end the following new part:

16 RESEARCH AND CAREGIVING TRUST FUND

"Sec. 6097. Contribution to the Alzheimer's Research and Caregiving Trust Fund

- 17 "SEC. 6097. CONTRIBUTION TO THE ALZHEIMER'S RE-
- 18 SEARCH AND CAREGIVING TRUST FUND.
- 19 "Every individual may elect, at the time of filing the
- 20 return of the tax imposed by chapter 1, to contribute a
- 21 whole dollar amount to be paid over to the Alzheimer's
- 22 Research and Caregiving Trust Fund.".

- 1 (b) CLERICAL AMENDMENT.—The table of parts for
- 2 such subchapter A of such Code is amended by adding
- 3 at the end the following new item:

"Part IX. Contribution to the Alzheimer's Research and Caregiving Trust Fund.".

- 4 (c) Effective Date.—The amendments made by
- 5 this section shall apply to taxable years ending after De-
- 6 cember 31, 2021.
