Mr. ZELDIN (for himself, Ms. STEFANIK, Miss RICE of New York, Mr. SUOZZI, Mr. COLLINS of New York, and Mr. KING of New York) introduced the following bill; which was referred to the Committee on Veterans' Affairs

A BILL

To authorize the Secretary of Veterans Affairs to make grants to State and local entities to carry out peer-to-peer mental health programs.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “PFC Joseph P. Dwyer
5 Peer Support Program Act”.

6 **SEC. 2. P.F.C. JOSEPH P. DWYER PEER SUPPORT PROGRAM.**

7 (a) IN GENERAL.—The Secretary of Veterans Affairs
8 shall establish a grant program to be known as the
9 “P.F.C. Joseph P. Dwyer Peer Support Program” under

1 which the Secretary shall make grants to eligible entities
2 for the purpose of establishing peer-to-peer mental health
3 programs for veterans.

4 (b) ELIGIBLE ENTITY DEFINED.—In this section,
5 the term “eligible entity” means any of the following enti-
6 ties that submit to the Secretary an application containing
7 such information and assurances as the Secretary may re-
8 quire:

9 (1) A nonprofit organization having historically
10 served veterans mental health needs.

11 (2) A congressionally chartered veteran service
12 organization.

13 (3) A State, local, or tribal veteran service
14 agency, director, or commissioner.

15 (c) AMOUNT OF GRANT.—The recipient of a grant
16 under this section shall receive a grant in an amount that
17 does not exceed \$250,000.

18 (d) USE OF FUNDS.—The recipient of a grant under
19 this section shall use the grant funds to—

20 (1) carry out a program that meets the stand-
21 ards developed under subsection (e);

22 (2) hire veterans to serve as peer specialists to
23 host group and individual meetings with veterans
24 seeking nonclinical support;

1 (3) provide mental health support to veterans
2 24 hours each day, seven days each week; and

3 (4) hire staff to support the program.

4 (e) PROGRAM STANDARDS.—

5 (1) ADVISORY COMMISSION.—The Secretary
6 shall establish an advisory committee for the pur-
7 pose of creating appropriate standards applicable to
8 programs established using grants under this sec-
9 tion.

10 (2) STANDARDS.—The standards developed
11 under paragraph (1) shall include initial and contin-
12 ued training for veteran peer volunteers, administra-
13 tive staffing needs, and best practices for addressing
14 the needs of each veteran served.

15 (f) NONRETENTION OF RECORDS.—The Secretary
16 may not require the recipient of a grant under this section
17 to maintain records on veterans seeking support or to re-
18 port any personally identifying information directly or in-
19 directly to the Secretary about such veterans.

20 (g) AUTHORIZATION OF APPROPRIATIONS.—There is
21 authorized to be appropriated \$25,000,000 to carry out
22 this section during the 3-year period beginning on the date
23 of the enactment of this Act.
