### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 14-19-3-4.

**Synopsis:** State park admission for disabled veterans. Provides that a disabled veteran may not be charged a fee for a Golden Hoosier Passport, which entitles the holder, the holder's vehicle, and passengers in the holder's vehicle to unlimited admission to state parks and other department of natural resources properties for which an admission fee is charged. Makes a technical correction.

**Effective:** July 1, 2017.

## SENATE BILL No. 142

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

1       SECTION 1. IC 14-19-3-4, AS AMENDED BY P.L.87-2010,  
2       SECTION 40, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3       JULY 1, 2017]: Sec. 4. (a) Upon application to the department, a  
4       resident of Indiana:

5       (1) who:

6           (A) if born in 1933, 1934, 1935, 1936, or 1937, is at least sixty  
7           (60) years of age; or

8           (B) if born before 1933 or after 1937, is at least sixty-five (65)  
9           years of age;

10       (2) who is eligible for Social Security disability payments under  
11       42 U.S.C. 423;

12       (3) who is eligible for a disabled Hoosier veteran license plate  
13       under ~~IC 9-18-18-1~~; **IC 9-18.5-5-1**; or

14       (4) who is issued a prisoner of war license plate under  
15       ~~IC 9-18-17-1~~; **IC 9-18.5-4-1**;

16       may purchase or is eligible to receive an annual Golden Hoosier  
17       Passport.



1 (b) A Golden Hoosier Passport entitles:

2 (1) the resident;

3 (2) the resident's motor vehicle; and

4 (3) the resident's passengers;

5 to unlimited admission for one (1) calendar year to the Indiana state  
6 parks ~~recreation areas, reservoirs, forests, historic sites, museums,~~  
7 ~~memorials,~~ and other ~~department~~ properties **administered by the**  
8 **department** for which admission is charged during the year for which  
9 the passport was issued.

10 (c) Except as provided in subsection (d), the fee for an annual  
11 Golden Hoosier Passport issued under this section is fifty percent  
12 (50%) of the fee that the department charges a resident who is not  
13 described in subsection (a)(1) **or** (a)(2) ~~or (a)(3)~~ for unlimited  
14 admission for one (1) calendar year to the Indiana state parks ~~recreation~~  
15 ~~areas, reservoirs, forests, historic sites, museums, memorials,~~ and other  
16 ~~department~~ properties **administered by the department** for which  
17 admission is charged.

18 (d) A fee may not be charged for an annual Golden Hoosier Passport  
19 issued under this section to a resident described in subsection **(a)(3) or**  
20 **(a)(4).**
