A RESOLUTION

- 1 Recognizing January 12, 2017, as Addiction Recovery Awareness Day to show that ongoing
- 2 recovery from substance use disorder is real and people do get better; and for other purposes.
- 3 WHEREAS, in 2015, over 27 million people in the United States reported current use of
- 4 illicit drugs or misuse of prescription drugs, and over 66 million people (over a quarter of the
- 5 adult and adolescent population) reported binge drinking in the past month; and
- 6 WHEREAS, neighborhoods and communities as a whole are also suffering as a result of
- 7 alcohol- and drug-related crime and violence, abuse and neglect of children, and the
- 8 increased costs of health care associated with substance misuse; and
- 9 WHEREAS, historically, our society has treated addiction and misuse of alcohol and drugs
- 10 as symptoms of moral weaknesses or as a willful rejection of societal norms, and these
- problems have been addressed primarily through our criminal justice system; and
- 12 WHEREAS, our health care system has not given the same level of attention to substance use
- disorders as it has to other health concerns that affect similar numbers of people; and
- 14 WHEREAS, the Georgia Senate Opioid Study Committee under the leadership of Senators
- 15 Renee Unterman and Butch Miller held in-depth meetings during the fall of 2016 to hear
- 16 testimony around current services, statistics, and best practices from researchers,
- 17 professionals, and people in recovery on the obstacles and opportunities to improve services
- 18 and supports; and
- 19 WHEREAS, through bipartisan efforts and support, two groundbreaking pieces of federal
- 20 legislation were passed in 2016 to provide guidance and resources to invest in new and
- 21 proven approaches to prevention, early intervention, treatment, and recovery for persons
- 22 struggling with addiction and substance misuse; and

WHEREAS, both the Comprehensive Addiction and Recovery Act and the 21st Century

- 24 Cures Act will provide states with the necessary tools to tackle the opioid epidemic; and
- 25 WHEREAS, recovery can be achieved through diverse pathways that should be celebrated,
- and the 25 million Americans in recovery and their families, including tens of thousands of
- 27 Georgians, have valuable experiences and encouragement to offer others who are struggling
- with substance use disorders.
- 29 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 30 recognize January 12, 2017, as Addiction Recovery Awareness Day.
- 31 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 32 to make appropriate copies of this resolution available for distribution to the public and the
- 33 press.
