A BILL

To rename the Saint Lawrence Seaway Development Corporation the Great Lakes St. Lawrence Seaway Development Corporation.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. GREAT LAKES ST. LAWRENCE SEAWAY DEVEL-**
4 **OPMENT CORPORATION.**

5 (a) RENAMING THE SAINT LAWRENCE SEAWAY DE-
6 VELOPMENT CORPORATION.—The Act of May 13, 1954
7 (33 U.S.C. 981 et seq.) is amended—

1 (1) in section 1 (33 U.S.C. 981), by striking
2 “Saint Lawrence Seaway Development Corporation”
3 and inserting “Great Lakes St. Lawrence Seaway
4 Development Corporation”; and

5 (2) in section 2(b) (33 U.S.C. 982(b)), by strik-
6 ing “Saint Lawrence Seaway Development Corpora-
7 tion” and inserting “Great Lakes St. Lawrence Sea-
8 way Development Corporation”.

9 (b) REFERENCES.—Any reference to the Saint Law-
10 rence Seaway Development Corporation in any law, regu-
11 lation, document, record, Executive order, or other paper
12 of the United States shall be deemed to be a reference
13 to the Great Lakes St. Lawrence Seaway Development
14 Corporation.

21 way Development Corporation” and inserting
22 “Great Lakes St. Lawrence Seaway Develop-
23 ment Corporation”;

24 (C) in section 214(2)(B) (33 U.S.C.
25 2241(2)(B)), by striking “Saint Lawrence Sea-

1 way Development Corporation” and inserting
2 “Great Lakes St. Lawrence Seaway Develop-
3 ment Corporation”; and

4 (D) in section 1132(b) (33 U.S.C.
5 2309(b)), by striking “Saint Lawrence Seaway
6 Development Corporation” and inserting
7 “Great Lakes St. Lawrence Seaway Develop-

18 way Development Corporation”;

19 (C) in section 8503(c), by striking “Saint
20 Lawrence Seaway Development Corporation”
21 and inserting “Great Lakes St. Lawrence Sea-
22 way Development Corporation”;

23 (D) in section 55112(a)(3), by striking
24 “St. Lawrence Seaway Development Corpora-

tion” and inserting “Great Lakes St. Lawrence Seaway Development Corporation”;

(E) in section 55331(3), by striking “Saint Lawrence Seaway Development Corporation” and inserting “Great Lakes St. Lawrence Seaway Development Corporation”; and

(F) in section 70032, by striking “Saint Lawrence Seaway Development Corporation” and inserting “Great Lakes St. Lawrence Seaway Development Corporation” each place it appears.

(7) TITLE 49.—

(A) IN GENERAL.—Chapter 1 of subtitle I title 49, United States Code, is amended—

(i) in section 110—

(I) in the heading, by striking “**Saint Lawrence Seaway Development Corporation**” and inserting “**Great Lakes St. Lawrence Seaway Development Corporation**”; and

(II) in subsection (a), by striking “Saint Lawrence Seaway Development Corporation” and inserting “Great

1 Lakes St. Lawrence Seaway Develop-
2 ment Corporation”; and

3 (ii) in section 6314(c)(2)(G), by strik-
4 ing “Saint Lawrence Seaway Development
5 Corporation” and inserting “Great Lakes
6 St. Lawrence Seaway Development Cor-
7 poration”.

8 (B) TABLE OF SECTIONS.—The table of
9 sections for chapter 1 of subtitle I of title 49,
10 United States Code, is amended by amending
11 the item relating to section 110 to read as fol-
12 lows:

“110. Great Lakes St. Lawrence Seaway Development Corporation.”.
