## **A BILL**

To amend chapter 3081 of title 54, United States Code,  
to enhance the protection and preservation of America's  
battlefields.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “American Battlefield*  
5 *Protection Program Enhancement Act of 2023”.*

6 **SEC. 2. AMERICAN BATTLEFIELD PROTECTION PROGRAM**  
7 **IMPROVEMENTS.**

8 *(a) DEFINITIONS.—Section 308101 of title 54, United*  
9 *States Code, is amended to read as follows:*

10 **“§ 308101. Definitions**

11 *“In this chapter:*

12 *“(1) SECRETARY.—The term ‘Secretary’ means*  
13 *the Secretary, acting through the American Battle-*  
14 *field Protection Program.*

15 *“(2) BATTLEFIELD REPORTS.—The term ‘Battle-*  
16 *field Reports’ means, collectively—*

17 *“(A) the document entitled ‘Report on the*  
18 *Nation’s Civil War Battlefields’, prepared by the*  
19 *Civil War Sites Advisory Commission, and*  
20 *dated July 1993; and*

21 *“(B) the document entitled ‘Report to Con-*  
22 *gress on the Historic Preservation of Revolu-*  
23 *tionary War and War of 1812 Sites in the*  
24 *United States’, prepared by the National Park*  
25 *Service, and dated September 2007.”.*

1       (b) *PRESERVATION ASSISTANCE*.—Section 308102(a)  
2 of title 54, United States Code, is amended by striking  
3 “Federal” and all that follows through “organizations” and  
4 inserting “Federal agencies, States, Tribes, local govern-  
5 ments, other public entities, educational institutions, and  
6 nonprofit organizations”.

7       (c) *BATTLEFIELD LAND ACQUISITION GRANTS IM-*  
8 *PROVEMENTS*.—Section 308103 of title 54, United States  
9 Code, is amended—

10           (1) by amending subsection (a) to read as fol-  
11 lows:

12       “(a) *ELIGIBLE SITE DEFINED*.—In this section, the  
13 term ‘eligible site’—

14           “(1) means a site that—

15               “(A) is not within the exterior boundaries of  
16 a unit of the National Park System; and

17               “(B) is identified in the Battlefield Reports  
18 as a battlefield; and

19           “(2) excludes sites identified in the Battlefield  
20 Reports as associated historic sites.”;

21       (2) in subsection (b), by striking “State and  
22 local governments” and inserting “States, Tribes,  
23 local governments, and nonprofit organizations”;

1           (3) *in subsection (c), by striking “State or local*  
2           *government” and inserting “State, Tribe, or local gov-*  
3           *ernment”;* and

4           (4) *in subsection (e), by striking “under this sec-*  
5           *tion” and inserting “under this section, including by*  
6           *States, Tribes, local governments, and nonprofit orga-*  
7           *nizations.”.*

8           (d) *BATTLEFIELD RESTORATION GRANTS IMPROVE-*  
9           *MENTS.—Section 308105 of title 54, United States Code,*  
10          *is amended—*

11           (1) *by amending subsection (a) to read as fol-*  
12          *lows:*

13           “(a) *ESTABLISHMENT.—The Secretary shall establish*  
14          *a battlefield restoration grant program (referred to in this*  
15          *section as the ‘program’) under which the Secretary may*  
16          *provide grants to States, Tribes, local governments, and*  
17          *nonprofit organizations for projects that restore day-of-bat-*  
18          *tle conditions on—*

19           “(1) *land preserved and protected under the bat-*  
20          *tlefield acquisition grant program established under*  
21          *section 308103(b); or*

22           “(2) *battlefield land that is—*

23           “(A) *owned by a State, Tribe, local govern-*  
24          *ment, or nonprofit organization; and*

1                   “(B) referred to in the Battlefield Reports.”;

2                   and

3                   (2) by striking subsection (b) and inserting the  
4                   following:

5                   “(b) *ELIGIBLE SITES.*—The Secretary may make  
6                   grants under this section for Revolutionary War, War of  
7                   1812, and Civil War battlefield sites—

8                   “(1) eligible for assistance under the battlefield  
9                   acquisition grant program established under section  
10                  308103(b); or

11                  “(2) on battlefield land that is—

12                   “(A) owned by a State, Tribe, local govern-  
13                   ment, or nonprofit organization; and

14                   “(B) referred to in the Battlefield Reports.”.

15                  (e) *UPDATES AND IMPROVEMENTS.*—Chapter 3081 of  
16                  title 54, United States Code, is amended by adding at the  
17                  end the following:

18                  “**§308106. Updates and improvements to Battlefield**  
19                                 **Reports**

20                   “Not later than 2 years after the date of the enactment  
21                   of this section, and every 10 years thereafter, the Secretary  
22                   shall submit to Congress a report that updates the Battle-  
23                   field Reports to reflect—

1           “(1) *preservation activities carried out at the*  
2           *battlefields in the period since the publication of the*  
3           *most recent Battlefield Reports update;*

4           “(2) *changes in the condition, including core and*  
5           *study areas, of the battlefields during that period; and*

6           “(3) *any other relevant developments relating to*  
7           *the battlefields during that period.*”.

8           (f) *CLERICAL AMENDMENT.—The table of sections for*  
9           *chapter 3081 of title 54, United States Code, is amended*  
10          *as follows:*

11           (1) *By amending the item relating to section*  
12          *308101 to read as follows:*

          “308101. *Definitions.*”.

13           (2) *By adding at the end the following:*

          “308106. *Updates and improvements to Battlefield Reports.*”.
