# Natural Resources – Licensed Tree Experts – Alterations

- 3 FOR the purpose of prohibiting a person from <u>physically</u> engaging in the work of the treatment, care, or removal of certain trees for compensation under a tree expert's 4  $\mathbf{5}$ license unless the person is employed by the licensed tree expert, employs a licensed 6 tree expert who can provide oversight, is employed by a company that employs a 7 licensed tree expert who can provide oversight, or is a licensed tree expert; increasing a certain penalty for operating a tree expert business without a license; repealing 8 9 certain electronic reporting requirements for licensed tree experts; requiring a 10 licensed tree expert to carry, show proof of, and maintain for a certain period of time 11 valid workers' compensation insurance; altering the requirements and procedures 12 for a licensed tree expert to possess and show proof of certain insurance; and 13generally relating to licensed tree experts.

IMPRISONMENT NOT EXCEEDING 1 YEAR OR A FINE NOT EXCEEDING \$2,000 OR BOTH. A licensed tree expert shall within a time period established by the (b) Department notify the Department electronically of: (1)Any company that engages in the business or work of the treatment, care, or removal of trees for compensation under the tree expert's license, and any changes to that status; and (2)The liability and property damage insurance and workers' compensation insurance carried by any company that engages or works under the tree expert's license, and any changes to the insurance.] **(C)** A PERSON MAY NOT <u>PHYSICALLY</u> ENGAGE IN THE WORK OF THE TREATMENT, CARE, OR REMOVAL OF TREES FOR COMPENSATION UNDER A TREE EXPERT'S LICENSE UNLESS THE PERSON IS: (1) IS EMPLOYED BY THE LICENSED TREE EXPERT; (2) EMPLOYS A LICENSED TREE EXPERT WHO CAN PROVIDE **OVERSIGHT;** (3) IS EMPLOYED BY A COMPANY THAT EMPLOYS A LICENSED TREE EXPERT WHO CAN PROVIDE OVERSIGHT; OR (4) IS A LICENSED TREE EXPERT. 5 - 418. The Department may examine an applicant for license as a tree expert and (a) pass upon the competence of the applicant. It shall issue a "tree expert" license to any applicant, who: Pays the fee provided in § 5–419 of this subtitle; (1)(2)Has attained 18 years of age;

1 (3) (i) Has had 2 years of approved college education in forestry, 2 arboriculture, horticulture, applied agricultural sciences, or the equivalent education and 3 a minimum of 1 year of experience with a licensed tree expert in Maryland or with an 4 acceptable tree expert company in another state; or

5 (ii) For at least 3 years immediately preceding the date of application 6 has been engaged continuously in practice as a tree expert with a licensed tree expert in 7 Maryland or with an acceptable tree expert company in another state; and

- 8 (4) Has passed the examination given by the Department.
- 9 (b) (1) Every licensee shall [carry and show]:

(I) POSSESS proof of VALID liability and property damage
insurance, AND WORKERS' COMPENSATION INSURANCE IF REQUIRED BY LAW, in the
form and amount required by the Department, AT ANY TIME THE LICENSEE IS ENGAGED
IN THE WORK OR BUSINESS OF A TREE EXPERT; AND

14 (II) SHOW PROOF OF THE REQUIRED INSURANCE at the time [it 15 issues] the license IS ISSUED AND WITH EACH LICENSE RENEWAL.

16 (2) The licensee shall maintain the insurance protection for the period the 17 license is in effect.

18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 October 1, 2023.
