Mr. Roy introduced the following bill; which was referred to the Committee on Oversight and Reform, and in addition to the Committee on the Judiciary, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To establish Federal Regulatory Review Commissions, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE; TABLE OF CONTENTS.
- 4 This Act may be cited as the "Coronavirus Regu-
- 5 latory Repeal Act of 2020".
- 6 SEC. 2. REPEAL OR MODIFICATION OF REGULATIONS DUR-
- 7 ING THE EMERGENCY PERIOD.
- 8 Any regulation waived or modified during the emer-
- 9 gency period shall be repealed or modified, as applicable,

- 1 the day after the expiration of the emergency period and
- 2 thereafter, unless a Federal Regulatory Review Commis-
- 3 sion recommends the regulation should not be repealed or
- 4 modified, as applicable, and a law is enacted confirming
- 5 the recommendation.

6 SEC. 3. FEDERAL REGULATORY REVIEW COMMISSIONS.

- 7 (a) Establishment.—There are established Com-
- 8 missions to be known as the "Federal Regulatory Review
- 9 Commissions".
- 10 (b) Members.—Each Commission shall be composed
- 11 of members of the congressional committee of each juris-
- 12 diction and the head of each agency under the jurisdiction
- 13 of that committee (in this Act referred to as the "mem-
- 14 bers").
- 15 (c) Information.—Members may obtain informa-
- 16 tion from individuals with expertise in the operations and
- 17 regulations of government programs.
- 18 (d) Duties of the Commissions.—
- 19 (1) REVIEW OF FEDERAL REGULATIONS.—Not
- later than 2 months after the date of the enactment
- of this Act, each Commission shall submit to the
- 22 Speaker of the House of Representatives and the
- 23 majority leader of the Senate an official rec-
- ommendation, on the repeal or modification of each
- regulation waived or modified during the emergency

- period. Each regulation waived or modified during the emergency period shall remain waived or modified, as applicable, during the review period by the Commission.
 - (2) EXTENSION.—The deadline in paragraph
 (1) may be extended for an additional month if the
 Congress enacts legislation extending such deadline
 by a vote of a majority of the House of Representatives and the Senate.

(e) Report to Congress.—

- (1) AGENCY REPORT ON REGULATIONS.—Not later than 1 month after the date of the enactment of this Act, the head of each agency shall submit to each congressional committee of jurisdiction a report that includes—
 - (A) an analysis of whether or not the agency can function without the regulation or with the modified regulation, as applicable; and
 - (B) an analysis of whether the regulation should be restored to its original state before the emergency period or should remain repealed or modified, as applicable.
- (2) Public comment period required.—The head of an agency shall provide a public comment

- 1 period before submitting a report pursuant to para-
- $2 \qquad \text{graph } (1).$
- 3 (f) Congressional Recommendation.—Not later
- 4 than 1 month after receiving a report from the head of
- 5 each agency pursuant to subsection (e), each committee
- 6 shall submit to the Speaker of the House of Representa-
- 7 tives and the majority leader of the Senate an official rec-
- 8 ommendation on whether or not the repealed or modified
- 9 regulation should be re-established.
- 10 (g) SUNSET OF COMMISSIONS.—The Commissions
- 11 established in this section shall terminate on the final day
- 12 of the final recommendation by each committee.
- 13 SEC. 4. DEFINITIONS.
- 14 In this Act:
- 15 (1) AGENCY.—The term "agency" has the
- meaning given that term in section 551 of title 5,
- 17 United States Code.
- 18 (2) Emergency Period.—The term "emer-
- 19 gency period" means the duration of a public health
- emergency declared pursuant to section 319 of the
- Public Health Service Act (42 U.S.C. 247d) as a re-
- sult of confirmed cases of 2019 novel coronavirus
- 23 (COVID-19), including any renewal thereof.

1	(3) Regulation.—The term "regulation" has
2	the meaning given the term "rule" under section
3	551 of title 5, United States Code.
