3 FOR the purpose of including a member of the Motor Vehicle Administration Police in the
4 defined term “police officer” in connection with provisions of law relating to the
5 authority to make arrests; including a member of the Motor Vehicle Administration
6 Police in the defined term “law enforcement officer” in connection with provisions of
7 law relating to the Maryland Police Training and Standards Commission and the
8 Law Enforcement Officers’ Bill of Rights; and generally relating to the Motor Vehicle
9 Administration Police.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Criminal Procedure

2–101.

(a) In this title the following words have the meanings indicated.

(c) “Police officer” means a person who in an official capacity is authorized by law
to make arrests and is:

(25) a member of the police force of the Anne Arundel Community College;

[or]

(26) a member of the police department of the Johns Hopkins University
established in accordance with Title 24, Subtitle 12 of the Education Article; **OR**

(27) A MEMBER OF THE MOTOR VEHICLE ADMINISTRATION POLICE.

Article – Public Safety

3–101.

(a) In this subtitle the following words have the meanings indicated.

(e) (1) “Law enforcement officer” means an individual who:

(i) in an official capacity is authorized by law to make arrests; and

(ii) is a member of one of the following law enforcement agencies:

25. the police force of the Anne Arundel Community College;

[or]

26. the police department of the Johns Hopkins University
established in accordance with Title 24, Subtitle 12 of the Education Article; **OR**

27. THE MOTOR VEHICLE ADMINISTRATION POLICE.

3–201.

(a) In this subtitle the following words have the meanings indicated.

(f) (1) “Police officer” means an individual who:

(i) is authorized to enforce the general criminal laws of the State;

and

(ii) is a member of one of the following law enforcement agencies:

21. the police force of the Anne Arundel Community College;

[or]

22. the police department of the Johns Hopkins University
established in accordance with Title 24, Subtitle 12 of the Education Article; **OR**

23. THE MOTOR VEHICLE ADMINISTRATION POLICE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
October 1, 2020.
