A BILL

To establish the White Sands National Park in the State of New Mexico as a unit of the National Park System, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. ESTABLISHMENT OF WHITE SANDS NATIONAL
- 4 PARK.
- 5 (a) DEFINITIONS.—In this section:
- 6 (1) MONUMENT.—The term "Monument"
- 7 means the White Sands National Monument, New
- 8 Mexico, established by Presidential Proclamation
- 9 No. 2025 (54 U.S.C. 320301 note), dated January
- 10 18, 1933, and administered by the Secretary.

| 9 | enhance visitor experiences, there is established in the |
| 10 | State of New Mexico the White Sands National Park as |
| 11 | a unit of the National Park System. |
| 12 | (c) Abolishment of White Sands National |
| 13 | MONUMENT.— |
| 14 | (1) Abolishment.—Due to the establishment |
| 15 | of the Park, the Monument is abolished. |
| 16 | (2) Incorporation.—The land and interests |
| 17 | in land that comprise the Monument are incor- |
| 18 | porated in, and shall be considered to be part of, the |
| 19 | Park. |
| 20 | (d) References.—Any reference in a law, map, reg- |
| 21 | ulation, document, paper, or other record of the United |
| 22 | States to the "White Sands National Monument" shall be |
| 23 | considered to be a reference to the "White Sands National |
| 24 | Park". |

1 (e) AVAILABILITY OF FUNDS.—Any funds available for the Monument shall be available for the Park. 3 (f) Administration.—The Secretary shall administer the Park in accordance with— 5 (1) this section; and 6 (2) the laws generally applicable to units of the 7 National Park System, including section 100101(a), 8 chapter 1003, sections 100751(a), 100752, 100753, 9 and 102101, and chapter 3201 of title 54, United 10 States Code. 11 (g) World Heritage List Nomination.— 12 (1) County concurrence.—The Secretary 13 shall not submit a nomination for the Park to be in-14 cluded on the World Heritage List of the United 15 Nations Educational, Scientific and Cultural Organi-16 zation unless each county in which the Park is lo-17 cated concurs in the nomination. 18 (2) ARMY NOTIFICATION.—Before submitting a 19 nomination for the Park to be included on the World 20 Heritage List of the United Nations Educational, 21 Scientific and Cultural Organization, the Secretary 22 shall notify the Secretary of the Army of the intent 23 of the Secretary to nominate the Park. 24 (h) Effect.—Nothing in this section affects—
