AN ACT

To amend the Peace Corps Act to expand services and benefits for volunteers, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

- 3 (1) Appropriate congressional commit-
- 4 TEES.—The term "appropriate congressional com-
- 5 mittees" means—
- 6 (A) the Committee on Foreign Relations of
- 7 the Senate;
- 8 (B) the Committee on Appropriations of
- 9 the Senate;
- 10 (C) the Committee on Foreign Affairs of
- the House of Representatives; and
- 12 (D) the Committee on Appropriations of
- the House of Representatives.
- 14 (2) DIRECTOR.—The term "Director" means
- the Director of the Peace Corps.
- 16 (3) Peace corps volunteer.—The term
- 17 "Peace Corps volunteer" means an individual de-

2	U.S.C. 2504(a)).
3	TITLE I—PEACE CORPS
4	VOLUNTEER SUPPORT
5	SEC. 101. PEACE CORPS VOLUNTEER MEDICAL CARE RE-
6	FORM.
7	(a) In General.—The Peace Corps Act is amend-
8	ed—
9	(1) in section 5 (22 U.S.C. 2504)—
10	(A) in subsection (e), in the first sentence,
11	by striking "receive such immunization and
12	dental care preparatory to their service" and in-
13	serting "receive, preparatory to their service,
14	such immunization, dental care, and informa-
15	tion on prescription options and potential inter-
16	actions, as necessary and appropriate and in ac-
17	cordance with subsection (f)";
18	(B) by re-designating subsections (f), (g),
19	(h), (i), (j), (k), (l), (m), and (n) as subsections
20	(g), (h), (i), (j), (k), (l), (m), (n), and (o);
21	(C) by inserting after subsection (e) the
22	following new subsection—
23	"(f) The Director of the Peace Corps shall consult
24	with health experts outside the Peace Corps, including ex-
25	perts licensed in the field of mental health, and follow

1	guidance by the Centers for Disease Control and Preven-
2	tion regarding the prescription of medications to a volun-
3	teer."; and
4	(D) in subsection (i), as so redesignated,
5	by striking "section, and" and inserting "sec-
6	tion), and"; and
7	(2) by inserting after section 5 the following
8	new section:
9	"SEC. 5A. HEALTH CARE FOR VOLUNTEERS AT PEACE
10	CORPS POSTS.
11	"(a) In General.—The President shall ensure that
12	each overseas post has the services of a medical office that
13	is consistent in size and scope with the needs of the Peace
14	Corps at such post, including, if necessary, by detailing
15	to any such post the licensed medical staff of other United
16	States departments, agencies, or establishments.
17	"(b) Hiring Criteria.—In selecting medical officers
18	and support staff for overseas Peace Corps posts, the Di-
19	rector of the Peace Corps shall hire well-qualified and ca-
20	pable personnel to support the effectiveness of health care
21	for Peace Corps volunteers by evaluating each can-
22	didate's—
23	"(1) medical training, experience, and accredi-
24	tations or other qualifications;
25	"(2) record of performance;

1	"(3) administrative capabilities;
2	"(4) understanding of the local language and
3	culture;
4	"(5) ability to work in the English language;
5	"(6) interpersonal skills; and
6	"(7) such other factors that the Director deter-
7	mines appropriate.
8	"(c) Certain Training.—The Director of the Peace
9	Corps shall ensure that each Peace Corps medical officer
10	serving in a malaria-endemic country receives training in
11	the recognition of the side effects of such medications.
12	"(d) REVIEW AND EVALUATION.—
13	"(1) IN GENERAL.—The Director of the Peace
14	Corps, acting through the Associate Director of the
15	Office of Health Services and the country directors
16	shall review and evaluate the performance and
17	health care delivery of all Peace Corps medical staff
18	including medical officers, to—
19	"(A) ensure compliance with all relevant
20	Peace Corps policies, practices, and guidelines
21	and
22	"(B) ensure that medical staff complete
23	the necessary continuing medical education to
24	maintain their skills and satisfy licensing and

- 1 credentialing standards, as designated by the
- 2 Director.
- 3 "(2) Report to congress.—The Director of
- the Peace Corps shall include, in the annual Peace
- 5 Corps congressional budget justification, a confirma-
- 6 tion that the review and evaluation of all Peace
- 7 Corps medical staff required under paragraph (1)
- 8 has been completed.
- 9 "(e) Antimalarial Drugs.—The Director of the
- 10 Peace Corps shall consult with experts at the Centers for
- 11 Disease Control and Prevention regarding recommenda-
- 12 tions for prescribing malaria prophylaxis, in order to pro-
- 13 vide the best standard of care within the context of the
- 14 Peace Corps environment.".
- 15 (b) Implementation of Recommendations by
- 16 THE INSPECTOR GENERAL OF THE PEACE CORPS.—
- 17 (1) Inspector general report.—As prompt-
- 18 ly as practicable, the Director shall implement the
- actions outlined in the agency response for all open
- 20 recommendations of the Inspector General of the
- 21 Peace Corps set forth in the report entitled "Final
- 22 Program Evaluation Report: OIG Follow-up Evalua-
- tion of Issues Identified in the 2010 Peace Corps/
- 24 Morocco Assessment of Medical Care" (Report No.
- 25 IG-16-01-E).

(2) Semiannual reports.—

- (A) Initial Report.—Not later than 180 days after the date of the enactment of this Act, the Director shall submit a report to the appropriate congressional committees that describes the Director's strategy for implementing the recommendations referred to in paragraph (1).
- (B) Subsequent reports.—Not later than 180 days after the submission of the report required under subparagraph (A), and semiannually thereafter, the Director shall submit a report to the appropriate congressional committees that describes the progress in implementing the recommendations referred to in paragraph (1) until all such recommendations have been implemented in accordance with the agency's response to the report referred to in such paragraph.
- (3) Notification.—After the submission of each report required under paragraph (2), the Inspector General of the Peace Corps may notify the appropriate congressional committees of any recommendations from the report referred to in para-

- 1 graph (1) that the Inspector General determines re-
- 2 main unresolved.
- 3 SEC. 102. POST-SERVICE PEACE CORPS VOLUNTEER MED-
- 4 ICAL CARE REFORM.
- 5 Section 8142 of title 5, United States Code, is
- 6 amended by adding at the end the following new sub-
- 7 section:
- 8 "(d)(1) The Secretary shall authorize the Director of
- 9 the Peace Corps to furnish medical benefits to a volunteer,
- 10 who is injured during the volunteer's period of service, for
- 11 a period of 120 days following the termination of such
- 12 service if the Director certifies that the volunteer's injury
- 13 probably meets the requirements under subsection (c)(3).
- 14 The Secretary may then certify vouchers for these ex-
- 15 penses for such volunteer out of the Employees' Com-
- 16 pensation Fund.
- 17 "(2) The Secretary shall prescribe the form and con-
- 18 tent of the certification required under paragraph (1).
- 19 "(3) A certification under paragraph (1) will cease
- 20 to be effective if the volunteer sustains compensable dis-
- 21 ability in connection with volunteer service.
- 22 "(4) Nothing in this subsection may be construed to
- 23 authorize the furnishing of any medical benefit that the
- 24 Secretary of Labor is not otherwise authorized to reim-
- 25 burse for former Peace Corps volunteers who receive treat-

- 1 ment for injury or disease proximately caused by their
- 2 service in the Peace Corps in accordance with this chap-
- 3 ter.".

4 SEC. 103. PEACE CORPS IMPACT SURVEY.

- 5 (a) IN GENERAL.—Beginning not later than 1 year
- 6 after the date of the enactment of this Act and once every
- 7 2 years thereafter for the following 6 years, the Director
- 8 shall conduct a survey of former Peace Corps volunteers.
- 9 (b) Scope of Survey.—The survey required under
- 10 subsection (a) shall assess, with respect to each former
- 11 Peace Corps volunteer completing the survey, the impact
- 12 of the Peace Corps on the former volunteer, including the
- 13 volunteer's—
- 14 (1) well-being;
- 15 (2) career;
- 16 (3) civic engagement; and
- 17 (4) commitment to public service.
- 18 (c) Report.—The Director shall submit a report
- 19 containing the results of the survey conducted under sub-
- 20 section (a) to—
- 21 (1) the Committee on Foreign Relations of the
- Senate;
- 23 (2) the Committee on Foreign Affairs of the
- 24 House of Representatives;

1	(3) the Committee on Appropriations of the
2	Senate; and
3	(4) the Committee on Appropriations of the
4	House of Representatives.
5	SEC. 104. EXTENSION OF POSITIONS FOR PEACE CORPS EM-
6	PLOYEES.
7	Section 7(a) of the Peace Corps Act (22 U.S.C.
8	2506(a)) is amended by adding at the end the following
9	new paragraph:
10	"(8)(A) The Director of the Peace Corps may
11	designate Peace Corps positions as critical manage-
12	ment or management support positions that require
13	specialized technical or professional skills and knowl-
14	edge of Peace Corps operations. Such positions may
15	include positions in the following fields:
16	"(i) Volunteer health services.
17	"(ii) Financial management.
18	"(iii) Information technology.
19	"(iv) Procurement.
20	"(v) Personnel.
21	"(vi) Legal services.
22	"(vii) Safety and security.
23	"(B) Subject to subparagraphs (C) and (D),
24	with respect to positions designated pursuant to sub-
25	paragraph (A), the Director may make or extend re-

1	newable appointments or assignments under para-
2	graph (2) notwithstanding limitations under sub-
3	paragraphs (A) and (B) of paragraph (2) and para-
4	graph (5).
5	"(C) In exercising authority under subpara-
6	graph (B), the Director shall ensure that all deci-
7	sions regarding the appointment, assignment, or ex-
8	tension of employees to any position designated pur-
9	suant to subparagraph (A)—
10	"(i) are consistent with Federal law and
11	Peace Corps policy; and
12	"(ii) are based upon operational and pro-
13	grammatic factors.
14	"(D) The term of any appointment or assign-
15	ment to any position designated pursuant to sub-
16	paragraph (A) may not exceed 5 years.".
17	TITLE II—PEACE CORPS OVER-
18	SIGHT AND ACCOUNTABILITY
19	SEC. 201. PEACE CORPS VOLUNTEER ACCESS TO INSPEC-
20	TOR GENERAL.
21	Section 8 of the Peace Corps Act (22 U.S.C. 2507)
22	is amended—
23	(1) in subsection (a)—
24	(A) by striking "he" and inserting "the
25	President"; and

1 (B) by adding at the end the following new 2 sentences: "As part of the training provided to 3 all volunteers under subsection (a), and in co-4 ordination with the Inspector General of the Peace Corps, the President shall provide all vol-6 unteers with information regarding the mandate 7 of the Inspector General and the availability 8 (including contact information) of the Inspector 9 General and the Office of Victim Advocacy as 10 a resource for volunteers. The President shall 11 ensure that volunteers receive such information 12 at least once during training that occurs prior 13 to enrollment and at least once during each sig-14 nificant instance of training after enrollment."; 15 and 16 (2) by adding at the end the following new sub-17 section: 18 "(c) The President shall implement procedures to 19 maintain a record verifying each individual completing 20 training provided to meet each requirement in this section 21 and sections 8A, 8B, 8F, and 8G(b).". SEC. 202. PUBLICATION REQUIREMENT FOR VOLUNTEER 23 SURVEYS. 24 Section 8E of the Peace Corps Act (22 U.S.C. 2507e)

is amended—

1	(1) in subsection (b), in the first sentence—
2	(A) by inserting ", ensure that each such
3	plan includes a consideration of the results,
4	with respect to each such representative and the
5	country of service of each such representative,
6	of each survey conducted under subsection (c),"
7	after "standards for Peace Corps representa-
8	tives"; and
9	(B) by striking "and shall review" and in-
10	serting ", and review"; and
11	(2) in subsection (c)—
12	(A) in the first sentence, by striking
13	"2018" and inserting "2023"; and
14	(B) in the third sentence, by striking "sub-
15	section (a)" and inserting "subsection (b)"; and
16	(C) by adding at the end the following new
17	sentences: "The President shall publish, on a
18	publicly available website of the Peace Corps, a
19	report summarizing the results of each survey
20	related to volunteer satisfaction in each country
21	in which volunteers serve, and the early termi-
22	nation rate of volunteers serving in each such
23	country. The information published shall be
24	posted in an easily accessible place near the de-

1	scription of the appropriate country and shall
2	be written in an easily understood manner.".
3	SEC. 203. CONSULTATION WITH CONGRESS REQUIRED BE-
4	FORE OPENING OR CLOSING OVERSEAS OF-
5	FICES AND COUNTRY PROGRAMS.
6	Section 10 of the Peace Corps Act (22 U.S.C. 2509)
7	is amended by adding at the end the following new sub-
8	section:
9	"(k)(1) Except as provided in paragraph (2), the Di-
10	rector of the Peace Corps may not open, close, signifi-
11	cantly reduce, or suspend a domestic or overseas office or
12	country program unless the Director has notified and con-
13	sulted with the appropriate congressional committees at
14	least 15 days in advance.
15	"(2) The Director of the Peace Corps may waive the
16	application of paragraph (1) for a period of not more than
17	5 days after an action described in such paragraph if the
18	Director determines such action is necessary to ameliorate
19	a substantial security risk to Peace Corps volunteers or
20	other Peace Corps personnel.
21	"(3) For the purposes of this subsection, the term
22	'appropriate congressional committees' means—
23	"(A) the Committee on Foreign Affairs and the
24	Committee on Appropriations of the House of Rep-
25	resentatives: and

1	"(B) the Committee on Foreign Relations and
2	the Committee on Appropriations of the Senate.".
3	TITLE III—CRIME RISK
4	REDUCTION ENHANCEMENTS
5	SEC. 301. INDEPENDENT REVIEW OF VOLUNTEER DEATH.
6	Section 5 of the Peace Corps Act (22 U.S.C. 2504),
7	as amended by section 101 of this Act, is further amended
8	by adding at the end the following new subsection:
9	"(p)(1) Not later than 10 days after receiving notifi-
10	cation of the death of a volunteer, the President shall pro-
11	vide a briefing to the Inspector General of the Peace Corps
12	that includes—
13	"(A)(i) the available facts and circumstances
14	surrounding the death of the volunteer, including a
15	preliminary timeline of the events immediately pre-
16	ceding the death of the volunteer, subsequent actions
17	taken by the Peace Corps, and any information
18	available to the Peace Corps reflecting on the cause
19	or root cause of the death of the volunteer; and
20	"(ii) a description of any steps the Peace Corps
21	plans to take to inquire further into the cause or
22	root cause of the death of the volunteer, including
23	the anticipated date of the completion of such in-
24	quiry; or

1	"(B) an explanation of why the Peace Corps
2	has determined that no further inquiry into the
3	cause or root cause of the death of the volunteer is
4	necessary, including—
5	"(i) a description of the steps the Peace
6	Corps took to determine further inquiry was not
7	necessary; and
8	"(ii) the basis for such determination.
9	"(2) If the Peace Corps has performed or engaged
10	another entity to perform a root cause analysis or similar
11	report that describes the cause or root cause of a volunteer
12	death, the President shall provide the Inspector General
13	of the Peace Corps with—
14	"(A) a copy of all information provided to such
15	entity at the time such information is provided to
16	such entity or used by the Peace Corps to perform
17	the analysis;
18	"(B) a copy of any report or study received
19	from the entity or used by the Peace Corps to per-
20	form the analysis; and
21	"(C) any supporting documentation upon which
22	the Peace Corps or such entity relied to make its de-
23	termination, including the volunteer's complete med-
24	ical record, as soon as such information is available
25	to the Peace Corps.

- 1 "(3) If a volunteer dies, the Peace Corps shall take
- 2 reasonable measures, in accordance with local laws, to pre-
- 3 serve any information or material, in any medium or for-
- 4 mat, that may be relevant to determining the cause or root
- 5 cause of the death of the volunteer, including personal ef-
- 6 fects, medication, and other tangible items belonging to
- 7 the volunteer, as long as such measures do not interfere
- 8 with the legal procedures of the host country if the govern-
- 9 ment of the host country is exercising jurisdiction over the
- 10 investigation of such death. The Inspector General of the
- 11 Peace Corps shall be provided an opportunity to inspect
- 12 such items before their final disposition.
- 13 "(4) Consistent with the Inspector General Act of
- 14 1978 (5 U.S.C. App.), the Inspector General of the Peace
- 15 Corps may independently review the facts and cir-
- 16 cumstances surrounding the death of a volunteer and the
- 17 actions taken by the Peace Corps in responding to such
- 18 incident.
- 19 "(5) For the purposes of undertaking a review under
- 20 this section, an officer or employee of the United States
- 21 or a member of the Armed Forces may be detailed to the
- 22 Inspector General of the Peace Corps from another de-
- 23 partment of the United States Government on a nonreim-
- 24 bursable basis, as jointly agreed to by the Inspector Gen-
- 25 eral and the detailing department, for a period not to ex-

- 1 ceed 1 year. This paragraph may not be construed to limit
- 2 or modify any other source of authority for reimbursable
- 3 or nonreimbursable details. A nonreimbursable detail
- 4 made under this section may not be considered an aug-
- 5 mentation of the appropriations of the Peace Corps.
- 6 "(6) Upon request, the Peace Corps may make avail-
- 7 able necessary funds to the Inspector General of the Peace
- 8 Corps for reviews conducted by the Inspector General
- 9 under this section. The request shall be limited to costs
- 10 relating to hiring, procuring, or otherwise obtaining med-
- 11 ical-related experts or expert services, and associated trav-
- 12 el.
- 13 "(7) The undertaking of a review under this section
- 14 may not be considered a transfer of program operating
- 15 responsibilities to the Inspector General of the Peace
- 16 Corps.".
- 17 SEC. 302. ADDITIONAL DISCLOSURES TO APPLICANTS FOR
- 18 ENROLLMENT AS VOLUNTEERS.
- 19 Section 8A of the Peace Corps Act (22 U.S.C.
- 20 2507a(d)) is amended—
- 21 (1) by amending subsection (d) to read as fol-
- lows:
- 23 "(d) Information Regarding Crimes and
- 24 Risks.—

1	"(1) In general.—Each applicant for enroll-
2	ment as a volunteer shall be provided, with respect
3	to each country in which the applicant may be in-
4	vited to serve, with specific, aggregated, and easily
5	accessible information regarding crimes against and
6	risks to volunteers, including—
7	"(A) an overview of past crimes against
8	volunteers in such country, including statistics
9	regarding unreported crime collected through
10	anonymous surveys;
11	"(B) the current early termination rate of
12	volunteers serving in such country;
13	"(C) health risks prevalent in such coun-
14	$\operatorname{try};$
15	"(D) the nature and frequency of sexual
16	harassment reported by volunteers serving in
17	such country;
18	"(E) the extent and types of services pro-
19	vided by the Peace Corps to volunteers serving
20	in such country, including access to medical
21	care, counseling services, and assistance from
22	the Office of Victim Advocacy; and
23	"(F) the level of satisfaction reported by
24	volunteers serving in such country.

1	"(2) Option to timely decline.—Upon re-
2	ceiving information described in paragraph (1), the
3	applicant shall have the option to change the coun-
4	try of consideration and identify a substitute coun-
5	try."; and
6	(2) in subsection (f)(2)(B)(iii), by striking "vic-
7	tim advocates" and inserting "Victim's Advocates,".
8	SEC. 303. ADDITIONAL PROTECTIONS AGAINST SEXUAL
9	MISCONDUCT.
10	Section 8B(a) of the Peace Corps Act (22 U.S.C.
11	2507b(a)) is amended—
12	(1) in paragraph (3)—
13	(A) by striking "SARLs" and inserting
14	"any employee of the Peace Corps";
15	(B) by striking "Victim Advocate" and in-
16	serting "Victim's Advocate"; and
17	(C) by inserting "and require the Peace
18	Corps to designate the staff at each post who
19	shall be responsible for providing the services
20	described in subsection (c)" before the semi-
21	colon at the end;
22	(2) in paragraph (5), by striking "and" at the
23	end;
24	(3) in paragraph (6), by striking the period at
25	the end and inserting a semicolon; and

1	(4) by adding at the end the following new
2	paragraphs:
3	"(7) maintains a record documenting the resignation
4	of any employee or volunteer of the Peace Corps who re-
5	signs before a determination has been made regarding an
6	alleged violation of the sexual misconduct policy or other
7	serious policy violations;
8	"(8) takes into account the record maintained under
9	paragraph (7) before such employee or volunteer is hired,
10	enrolled, or otherwise invited to work with the Peace
11	Corps;
12	"(9) provides orientation or information regarding
13	the awareness and prevention of sexual assault and sexual
14	harassment to—
15	"(A) Peace Corps-selected host families; and
16	"(B) a designated person of authority at the
17	volunteer's initial workplace; and
18	"(10) ensures, to the extent practicable and appro-
19	priate, that any assault on, or any harm or injury to, a
20	volunteer that is committed by any member of a host fam-
21	ily or any national of a host country that was assigned
22	by the Peace Corps to facilitate volunteer work is—
23	"(A) documented in an appropriate site history
24	file and in the global tracking and recording system
25	established pursuant to section 8H(c): and

1	"(B) taken into account with respect to deter-
2	minations regarding placements of future volunteers
3	at such post and the provision of any funds or other
4	benefit by the Peace Corps.".
5	SEC. 304. EXTENSION OF THE OFFICE OF VICTIM ADVO-
6	CACY.
7	Section 8C of the Peace Corps Act (22 U.S.C. 2507c)
8	is amended—
9	(1) by striking "victim advocate" each place it
10	appears and inserting "Victim's Advocate";
11	(2) by striking "victim advocates" each place it
12	occurs and inserting "Victim's Advocates"; and
13	(3) by amending subsection (e) to read as fol-
14	lows:
15	"(e) The Director of the Peace Corps shall include
16	the head of the Office of Victim Advocacy in agency-wide
17	policymaking processes in the same manner and to the
18	same extent as the directors or associate directors of other
19	offices within the Peace Corps.".
20	SEC. 305. REFORM AND EXTENSION OF THE SEXUAL AS-
21	SAULT ADVISORY COUNCIL.
22	Section 8D of the Peace Corps Act (22 U.S.C.
23	2507d) is amended—
24	(1) in subsection (b)—

- (A) by striking "not less than 8 individuals selected by the President, not later than 180 days after the date of the enactment of this section," and inserting "not fewer than 8 and not more than 14 individuals selected by the President"; and
 - (B) by inserting after the first sentence the following new sentence: "At least one member should be licensed in the field of mental health and have prior experience working as a counselor or therapist providing mental health care to survivors of sexual assault in a victim services agency or organization."; and

(2) in subsection (c)—

- (A) by inserting "and implemented" after "sexual assault policy developed"; and
- (B) by adding at the end the following new sentence: "To carry out this subsection, the Council may conduct case reviews and is authorized to have access, including through interviews, to current and former volunteers (to the extent that such volunteers provide the Peace Corps express consent to be interviewed by the Council), to volunteer surveys under section 8E, to all data collected from restricted reporting,

1	and to any other information necessary to con-
