A BILL

- To direct the Librarian of Congress to carry out activities to support Armenian Genocide education programs, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Armenian Genocide3 Education Act".

4 SEC. 2. FINDINGS.

5 Congress finds the following:

6 (1) The United States has demonstrated a com-7 mitment to remembrance and education about the 8 Armenian Genocide of 1915–1923 through the 9 United States Government's May 28, 1951, written 10 statement to the International Court of Justice re-11 garding the Convention on the Prevention and Pun-12 ishment of the Crime of Genocide; through President 13 Ronald Reagan's Proclamation No. 4838 on April 14 22, 1981; by H.J. Res 148, adopted on April 8, 15 1975; H.J. Res 247, adopted on September 10, 16 1984; H. Res. 296, adopted on October 29, 2019; S. 17 Res. 150, adopted on December 12, 2019; and 18 President Joe Biden's April 24, 2021, statement 19 recognizing the Armenian Genocide.

20 (2) H. Res. 296 and S. Res. 150 cite the Otto21 man Empire's "campaign of genocide against Arme22 nian, Greek, Assyrian, Chaldean, Syriac, Aramean,
23 Maronite and other Christians", and call on the
24 United States to—

25 (A) "reject efforts to enlist, engage, or oth26 erwise associate the United States Government

with denial of the Armenian Genocide or any other genocide"; and

(B) "encourage education and public understanding of the facts of the Armenian Genocide, including the United States role in the humanitarian relief effort, and the relevance of the Armenian Genocide to modern-day crimes against humanity".

9 (3) Today, those who deny that the Ottoman 10 Empire systematically planned, organized, and im-11 plemented a campaign of genocide against Arme-12 nian, Greek, Assyrian, Chaldean, Syriac, Aramean, Maronite, and other Christians or who seek to dis-13 14 tort the true nature of these crimes continue to find 15 forums, especially online. This denial and distortion 16 dishonors those who were persecuted, murdered, dis-17 possessed, and exiled, making it even more of a na-18 tional imperative to educate students in the United 19 States so that they may explore the lessons that 20 these crimes provide for all people, sensitize commu-21 nities to the circumstances that gave rise to these 22 crimes, and help youth be less susceptible to the 23 falsehood of genocide denial and distortion and to 24 the destructive messages of hate that arise from de-25 nial and distortion.

1 SEC. 3. DEFINITIONS.

2 In this Act:

3 (1) ARMENIAN GENOCIDE.—The term "Arme-4 nian Genocide" means Ottoman Turkey's systematic 5 and deliberate state-sponsored mass murder, na-6 tional dispossession, cultural erasure, and exile of 7 millions of Armenians, Greeks, Assyrians, 8 Chaldeans, Syriacs, Arameans, Maronites, and other 9 Christians, between 1915 and 1923.

10 (2) Armenian genocide education pro-GRAM.—The term "Armenian Genocide education 11 12 program" means a program that has as its specific 13 and primary purpose the improvement of awareness 14 and understanding of the history, lessons, con-15 sequences, and ongoing costs of the Armenian Geno-16 cide, and which will serve as a means of promoting 17 justice and preventing genocide, hate, and bigotry 18 against any group of people.

19 (3) DENIAL.—The term "denial" refers to dis20 course and propaganda that claims that the Arme21 nian Genocide did not take place.

(4) DISTORTION.—The term "distortion" refers
specifically to any attempt to excuse or minimize, in
its entirety or in its principal elements, the Armenian Genocide, including efforts to blame the victims

18 (b) ACTIVITIES.—The activities described in this sub19 section are as follows:

(1) The development and national dissemination
of accurate, relevant, and accessible resources to
promote understanding about how and why the Armenian Genocide happened, which shall include digital resources and may include other types of re-

 the annual report required under section 8.

7 SEC. 5. ENGAGEMENT OF ELIGIBLE PROGRAM PARTICI-8 PANTS.

9 (a) AGREEMENTS WITH PROGRAM PARTICIPANTS.—
10 The Librarian of Congress may enter into agreements
11 with eligible entities under which such entities may serve
12 as program participants in the program established by this
13 Act.

(b) CONTENTS OF AGREEMENTS.—An agreement entered into under this section between the Librarian and
an eligible entity shall include the following elements:

17 (1) A description of the services and assistance18 provided to the entity by the Librarian.

19 (2) A description of the activities to be carried20 out by the entity with such services and assistance.

21 (3) The length of the period in which the agree-22 ment shall be in effect.

(4) Such other elements as may be agreed to by
the Librarian and the entity, consistent with the
program established by this Act.

(c) ELIGIBILITY.—An entity is eligible to serve as a
 program participant in the program established by this
 Act if—

4 (1) the entity is a local educational agency, a
5 school that is independent of any local educational
6 agency, or an entity that works with or for a local
7 educational agency or a school that is independent
8 of any local educational agency; and

9 (2) the entity submits to the Librarian, at such
10 time and in such form as the Librarian may require,
11 an application containing such information and as12 surances as the Librarian may require.

13 (d) PRIORITY.—In selecting among eligible entities for participating in the program established under this 14 15 Act, the Librarian shall give priority to applications from entities who are local educational agencies, schools that 16 are independent of any local educational agency, or enti-17 ties that work with or for a local educational agency or 18 19 a school that is independent of any local educational agen-20 cy, that do not, at the time application is made, offer any 21 Armenian Genocide education program.

22 SEC. 6. ONLINE EDUCATION RESOURCES.

(a) WEBSITE.—The Librarian of Congress shall
maintain on the website of the Library of Congress a publicly available special section designated for Armenian

Genocide education resources to improve awareness and
 understanding of this Genocide and educate individuals on
 the lessons of the Armenian Genocide as a means to raise
 awareness about the importance of preventing genocide,
 hate, and bigotry against any group of people.

6 (b) INFORMATION DISTRIBUTION.—The Librarian 7 shall distribute information about the activities funded 8 under this Act through the website of the Library of Con-9 gress, and shall respond to inquiries for supplementary in-10 formation concerning such activities.

(c) BEST PRACTICES.—The information distributed
by the Librarian under this section shall include best practices for educators on how to teach about the Armenian
Genocide.

15 SEC. 7. PRIVATE SUPPORT.

(a) ACCEPTANCE OF DONATIONS.—The Librarian of
Congress may solicit, accept, hold, administer, invest, and
use donated funds and gifts, bequests, and devises of property, both real and personal, to support the activities carried out under this Act, subject to subsection (c).

(b) ESTABLISHMENT OF SEPARATE GIFT ACCOUNT.—There is established in the Treasury (among the
accounts of the Library of Congress) a gift account for
the activities carried out under this Act.

(c) DEDICATION OF FUNDS.—Notwithstanding any
 other provision of law—

3 (1) any funds donated to the Librarian to carry
4 out activities under this Act shall be deposited en5 tirely into the gift account established under sub6 section (b);

7 (2) the funds contained in such account shall be
8 used solely to carry out activities under this Act; and
9 (3) the Librarian may not deposit into such ac10 count any funds donated to the Librarian which are
11 not donated for the exclusive purpose of carrying out
12 activities under this Act.

13 SEC. 8. ANNUAL REPORT.

14 Not later than February 1 of each year (beginning
15 with 2023), the Librarian of Congress shall submit to the
16 Congress a report describing the activities carried out
17 under this Act.

18 SEC. 9. AUTHORIZATION OF APPROPRIATIONS.

There are authorized to be appropriated to carry out
this Act \$2,000,000 for fiscal year 2023 and each of the
4 succeeding fiscal years.
