5 (a) ACQUISITION OF LAND.—

1	(1) AUTHORIZATION.—The Secretary of Health
2	and Human Services, acting through the Director of
3	the Indian Health Service, is authorized to acquire,
4	from willing sellers, the land in Hemet, California,
5	upon which is located a dirt road known as "Best
6	Road", beginning at the driveway of the Desert Sage
7	Youth Wellness Center at Faure Road and extending
8	to the junction of Best Road and Sage Road.
9	(2) Compensation.—The Secretary shall pay
10	fair market value for the land authorized to be ac-
11	quired under paragraph (1). Fair market value shall
12	be determined—
13	(A) using Uniform Appraisal Standards
14	for Federal Land Acquisitions; and
15	(B) by an appraiser acceptable to the Sec-
16	retary and the owners of the land to be ac-
17	quired.
18	(3) Additional rights.—In addition to the
19	land referred to in paragraph (1), the Secretary is
20	authorized to acquire, from willing sellers, land or
21	interests in land as reasonably necessary to con-
22	struct and maintain the road as required by sub-
23	section (b).
24	(b) Construction and Maintenance of Road.—

1	(1) CONSTRUCTION.—After the Secretary ac-
2	quires the land pursuant to subsection (a), the Sec-
3	retary shall construct on that land a paved road that
4	is generally located over Best Road to facilitate ac-
5	cess to the Desert Sage Youth Wellness Center in
6	Hemet, California.
7	(2) MAINTENANCE.—The Secretary—
8	(A) shall maintain and manage the road
9	constructed pursuant to paragraph $(1)$ ; or
10	(B) enter into an agreement with Riverside
11	County, California, to own, maintain and man-
12	age the road constructed pursuant to paragraph
13	(1).
