A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to ensure that the Federal Emergency Management Agency provides access to potable water for individuals during a public health emergency.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Water for Public
- 5 Health Act".

1 SEC. 2. ACCESS TO WATER.

2	The Robert T. Stafford Disaster Relief and Emer-
3	gency Assistance Act (42 U.S.C. 5141 et seq.) is amended:
4	(1) in section 403 by adding at the end the fol-
5	lowing:
6	"(e) Access to Water and Sanitation in a Pub-
7	LIC HEALTH EMERGENCY.—
8	"(1) In general.—Except as provided in para-
9	graph (2), during an emergency period (as defined
10	in section 1135(g)(1) of the Social Security Act (42
11	U.S.C. $1320b-5(g)(1)$), the President, acting
12	through the Administrator of the Federal Emer-
13	gency Management Agency, may—
14	"(A) through the use of Federal depart-
15	ments, agencies, and instrumentalities provide
16	every individual access to potable water and
17	basic sanitation; and
18	"(B) make grants to States, local govern-
19	ments, Indian tribal governments, and owners
20	or operators of private nonprofit facilities to as-
21	sist in carrying out subparagraph (A), which
22	may include—
23	"(i) installation of mobile water sta-
24	tions;
25	"(ii) installation of handwashing fa-
26	cilities;

1	"(iii) distribution or delivery of emer-
2	gency bottled water and personal and home
3	sanitization products;
4	"(iv) reconnection of water utility
5	service, regardless of when such service
6	was discontinued or for what reason; and
7	"(v) moratorium on water utility shut-
8	offs.
9	"(2) State and local government con-

15	(2) in section 502 by adding at the end the fol-
16	lowing:
17	"(d) Access to Water and Sanitation in a Pub-
