22	RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, That
23	this resolution may be cited as the "Modification Nos. 3, 4, and 5 to Contract No.
24	CW67661 with Sagitec Solutions LLC Approval and Payment Authorization Emergency
25	Declaration Resolution of 2020".
26	Sec. 2. (a) There exists an immediate need to approve Modification Nos. 3, 4,
27	and 5 to Contract No. CW67661 with Sagitec Solutions LLC., to provide a paid family
28	leave tax system solution, and to authorize payment for the goods and services received
29	and to be received under Modification Nos. 3, 4, and 5 to Contract No. CW67661.
30	(b) On January 23, 2020, by Modification No. 3, the Office of Contracting and
31	Procurement ("OCP"), on behalf of the District's Department of Employment Services,
32	exercised option year one of Contract No. CW67661 for the period February 21, 2020
33	through February 20, 2021 in the amount of \$711,750.

- 1 (c) On April 2, 2020, by Modification No. 4, OCP increased the amount for
- 2 option year one by \$60,000 to a total estimated amount of \$771,750.
- 3 (d) Modification No. 5 is now necessary to increase the amount for option year
- 4 one to \$1,071,300.
- 5 (e) Council approval is necessary since this will increase the value of the contract
- 6 to more than \$1 million during a 12-month period.
- 7 (f) Approval is necessary to allow the continuation of these vital services.
- 8 Without this approval, Sagitec Solutions LLC. cannot be paid for goods and services
- 9 provided in excess of \$1 million for the period February 21, 2020 through February 20,
- 10 2021.
- 11 Sec. 3. The Council of the District of Columbia determines that the
- 12 circumstances enumerated in section 2 constitute emergency circumstances making it
- 13 necessary that the Modification Nos. 3, 4, and 5 to Contract No. CW67661 with Sagitec
- 14 Solutions LLC. Approval and Payment Authorization Emergency Act of 2020 be adopted
- 15 after a single reading.
- 16 Sec. 4. This resolution shall take effect immediately.
