# **A BILL**

To establish centers of excellence for innovative stormwater control infrastructure, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Innovative Stormwater*  
5 *Infrastructure Act of 2018”.*

6 **SEC. 2. STORMWATER INFRASTRUCTURE FUNDING TASK**  
7 **FORCE.**

8 *(a) IN GENERAL.—Not later than 180 days after the*  
9 *date of enactment of this Act, the Administrator of the En-*  
10 *vironmental Protection Agency shall establish a stormwater*  
11 *infrastructure funding task force composed of representa-*  
12 *tives of Federal, State, and local governments and private*  
13 *(including nonprofit) entities to conduct a study on, and*  
14 *develop recommendations to improve, the availability of*  
15 *public and private sources of funding for the construction,*  
16 *rehabilitation, and operation and maintenance of*  
17 *stormwater infrastructure to meet the requirements of the*  
18 *Federal Water Pollution Control Act (33 U.S.C. 1251 et*  
19 *seq.).*

20 *(b) CONSIDERATIONS.—In carrying out subsection (a),*  
21 *the task force shall—*

22 *(1) identify existing Federal, State, and local*  
23 *public sources and private sources of funding for*  
24 *stormwater infrastructure; and*

25 *(2) consider—*

1           (A) *how funding for stormwater infrastruc-*  
2 *ture from such sources has been made available,*  
3 *and utilized, in each State to address stormwater*  
4 *infrastructure needs identified pursuant to sec-*  
5 *tion 516(b)(1) of the Federal Water Pollution*  
6 *Control Act (33 U.S.C. 1375(b)(1));*

7           (B) *how the source of funding affects the af-*  
8 *fordability of the infrastructure (as determined*  
9 *based on the considerations used to assess the fi-*  
10 *nancial capability of municipalities under the*  
11 *integrated planning guidelines described in the*  
12 *Integrated Municipal Stormwater and Waste-*  
13 *water Planning Approach Framework, issued by*  
14 *the Environmental Protection Agency on June 5,*  
15 *2012, and dated May, 2012), including consider-*  
16 *ation of the costs associated with financing the*  
17 *infrastructure; and*

18           (C) *whether such sources of funding are suf-*  
19 *ficient to support capital expenditures and long-*  
20 *term operation and maintenance costs necessary*  
21 *to meet the stormwater infrastructure needs of*  
22 *municipalities.*

23           (c) *REPORT.*—*Not later than 18 months after the date*  
24 *of enactment of this Act, the Administrator shall submit*  
25 *to Congress a report that describes the results of the study*

1 *conducted, and the recommendations developed, under sub-*  
2 *section (a).*

3 *(d) STATE DEFINED.—In this section, the term*  
4 *“State” has the meaning given that term in section 502*  
5 *of the Federal Water Pollution Control Act (33 U.S.C.*  
6 *1362).*

Amend the title so as to read: “A bill to direct the Administrator of the Environmental Protection Agency to establish a stormwater infrastructure funding task force, and for other purposes.”
