Expressing support for designation of April 2017 as "National Congenital Diaphragmatic Hernia Awareness Month".

## IN THE HOUSE OF REPRESENTATIVES

April 28, 2017

Mr. HOLDING (for himself, Mr. CONNOLLY, and Mr. MEEHAN) submitted the following resolution; which was referred to the Committee on Energy and Commerce

## **RESOLUTION**

- Expressing support for designation of April 2017 as "National Congenital Diaphragmatic Hernia Awareness Month".
- Whereas congenital diaphragmatic hernia (referred to in this preamble as "CDH") occurs when the diaphragm fails to fully form, allowing abdominal organs to migrate into the chest cavity and preventing lung growth;
- Whereas the Centers for Disease Control and Prevention recognizes CDH as a birth defect;
- Whereas the majority of CDH patients suffer from underdeveloped lungs or poor pulmonary function;
- Whereas babies born with CDH endure extended hospital stays in intensive care with multiple surgeries;

- Whereas CDH patients often endure long-term complications, such as pulmonary hypertension, pulmonary hypoplasia, asthma, gastrointestinal reflux, feeding disorders, and developmental delays;
- Whereas CDH survivors sometimes endure long-term mechanical ventilation dependency, skeletal malformations, supplemental oxygen dependency, enteral and parenteral nutrition, and hypoxic brain injury;
- Whereas CDH is treated through mechanical ventilation, a heart and lung bypass (commonly known as "extracorporeal membrane oxygenation"), machines, and surgical repair;
- Whereas surgical repair is often not a permanent solution for CDH and can lead to reherniation and require additional surgery;
- Whereas CDH is diagnosed in utero in less than 50 percent of cases;
- Whereas infants born with CDH have a high mortality rate, ranging from 20 to 60 percent, depending on the severity of the defect and interventions available at delivery;
- Whereas CDH has a rate of occurrence of 1 in every 2,500 live births worldwide;
- Whereas CDH affects approximately 1,600 babies each year in the United States;
- Whereas CDH has affected more than 700,000 babies worldwide since 2000;
- Whereas CDH does not discriminate based on race, gender, or socioeconomic status;
- Whereas the cause of CDH is unknown;

Whereas the average CDH survivor will face postnatal care

	of at least \$100,000; and
Who	ereas Federal support for CDH research at the National Institutes of Health for 2017 is estimated to be not more than \$4,000,000: Now, therefore, be it
1	Resolved, That the House of Representatives—
2	(1) supports the designation of "National Con-
3	genital Diaphragmatic Hernia Awareness Month";
4	(2) encourages that steps should be taken to—
5	(A) raise awareness of and increase public
6	knowledge about congenital diaphragmatic her-
7	nia (referred to in this resolution as "CDH");
8	(B) inform the people of the United States
9	about the dangers of CDH, especially those
10	groups that may be disproportionately affected
11	by CDH or have lower survival rates;
12	(C) disseminate information on the impor-
13	tance of quality neonatal care of CDH patients;
14	(D) promote quality prenatal care and
15	ultrasounds to detect CDH in utero; and
16	(E) support research funding of CDH to—
17	(i) improve screening and treatment
18	for CDH;
19	(ii) discover the causes of CDH; and
20	(iii) develop a cure for CDH; and

1	(3) calls on the people of the United States, in-
2	terest groups, and affected persons to—
3	(A) promote awareness of CDH;
4	(B) take an active role in the fight against
5	this devastating birth defect; and
6	(C) observe National Congenital Diaphrag-
7	matic Hernia Awareness Month with appro-
8	priate ceremonies and activities.
