AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take effect July 1, 2017, and shall be applicable to all taxable years beginning after December 31, 2016, but before January 1, 2019. It shall remain effective for a period of 2 years and, at the end of June 30, 2019, with no further action required by the General Assembly, Section 2 of this Act shall be abrogated and of no further force and effect.
12 13 14	SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2017, and, except as provided in Section 3 of this Act, shall be applicable to all taxable years beginning after December 31, 2016.
