A BILL

To amend title 38, United States Code, to provide veterans affected by school closures certain relief and restoration of educational benefits, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Department of Vet-
5 erans Affairs Veterans Education Relief and Restoration
6 Act of 2017”.

1 **SEC. 2. RESTORATION OF ENTITLEMENT TO EDUCATIONAL**
2 **ASSISTANCE AND OTHER RELIEF FOR VET-**
3 **ERANS AFFECTED BY SCHOOL CLOSURE.**

4 (a) EDUCATIONAL ASSISTANCE.—

5 (1) IN GENERAL.—Section 3312 of title 38,
6 United States Code, is amended by adding at the
7 end the following new subsection:

8 “(d) DISCONTINUATION OF EDUCATION DUE TO
9 SCHOOL CLOSURE.—

10 “(1) IN GENERAL.—Any payment of edu-
11 cational assistance described in paragraph (2) shall
12 not—

13 “(A) be charged against any entitlement to
14 educational assistance of the individual con-
15 cerned under this chapter; or

16 “(B) be counted against the aggregate pe-
17 riod for which section 3695 of this title limits
18 the individual’s receipt of educational assistance
19 under this chapter.

20 “(2) DESCRIPTION OF PAYMENT OF EDU-
21 CATIONAL ASSISTANCE.—Subject to paragraph (3),
22 the payment of educational assistance described in
23 this paragraph is the payment of such assistance to
24 an individual for pursuit of a course or courses
25 under this chapter if the Secretary finds that the in-
26 dividual—

1 “(A) was forced to discontinue such course
2 pursuit as a result of a permanent school clo-
3 sure; and

4 “(B) did not receive credit, or lost training
5 time, toward completion of the program of edu-
6 cation being pursued at the time of such clo-
7 sure.

8 “(3) PERIOD FOR WHICH PAYMENT NOT
9 CHARGED.—The period for which, by reason of this
10 subsection, educational assistance is not charged
11 against entitlement or counted toward the applicable
12 aggregate period under section 3695 of this title
13 shall not exceed the aggregate of—

14 “(A) the portion of the period of enroll-
15 ment in the course or courses from which the
16 individual failed to receive credit or with respect
17 to which the individual lost training time, as de-
18 termined under paragraph (2)(B); and

19 “(B) the period by which monthly stipend
20 is extended under section 3680(a)(2)(B) of this
21 title.”.

22 (2) APPLICABILITY.—Subsection (d) of such
23 section, as added by paragraph (1), shall apply with
24 respect to courses and programs of education discon-
25 tinued as described in subparagraph (A) or (B) of

1 paragraph (2) of such subsection in fiscal year 2015
2 or any fiscal year thereafter.

3 (b) MONTHLY HOUSING STIPEND.—

4 (1) IN GENERAL.—Section 3680(a) of such title
5 is amended—

6 (A) by striking the matter after paragraph
7 (3)(B);

8 (B) in paragraph (3), by redesignating
9 subparagraphs (A) and (B) as clauses (i) and
10 (ii), respectively;

11 (C) by redesignating paragraphs (1)
12 through (3) as subparagraphs (A) through (C),
13 respectively;

14 (D) in the matter before subparagraph
15 (A), as redesignated, in the first sentence, by
16 striking “Payment of” and inserting “(1) Ex-
17 cept as provided in paragraph (2), payment of”;
18 and

19 (E) by adding at the end the following new
20 paragraph (2):

21 “(2) Notwithstanding paragraph (1), the Secretary
22 may, pursuant to such regulations as the Secretary shall
23 prescribe, continue to pay allowances to eligible veterans
24 and eligible persons enrolled in courses set forth in para-
25 graph (1)(A)—

1 “(A) during periods when schools are tempo-
2 rarily closed under an established policy based on an
3 Executive order of the President or due to an emer-
4 gency situation, except that the total number of
5 weeks for which allowances may continue to be so
6 payable in any 12-month period may not exceed four
7 weeks; or

8 “(B) solely for the purpose of awarding a
9 monthly housing stipend described in section 3313
10 of this title, during periods following a permanent
11 school closure, except that payment of such a sti-
12 pend may only be continued until the earlier of—

13 “(i) the date of the end of the term, quar-
14 ter, or semester during which the school closure
15 occurred; and

16 “(ii) the date that is 4 months after the
17 date of the school closure.”.

18 (2) CONFORMING AMENDMENT.—Paragraph
19 (1)(C)(ii) of such section, as redesignated, is amend-
20 ed by striking “described in subclause (A) of this
21 clause” and inserting “described in clause (ii)”.
