Mr. HILL (for himself and Mr. LEWIS of Georgia) introduced the following
bill; which was referred to the Committee on Natural Resources

A BILL

To modify the boundary of the Little Rock Central High
School National Historic Site, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Little Rock Central
5 High School National Historic Site Boundary Modifica-
6 tion Act”.

7 **SEC. 2. LITTLE ROCK CENTRAL HIGH SCHOOL NATIONAL**
8 **HISTORIC SITE BOUNDARY MODIFICATION.**

9 Section 2 of Public Law 105–356 (112 Stat. 3268)
10 is amended—

1 (1) by redesignating subsections (b), (c), (d),
2 and (e) as subsections (c), (d), (e), and (f), respec-
3 tively;

4 (2) by inserting after subsection (a) the fol-
5 lowing:

6 “(b) BOUNDARY MODIFICATION.—The boundary of
7 the historic site is modified to include the 7 residences
8 on South Park Street in Little Rock, Arkansas, consisting
9 of 1.47 acres, as generally depicted on the map entitled
10 ‘Central High School National Historic Site Proposed
11 Boundary’, numbered 037/80,001, and dated August,
12 2004.”; and

13 (3) in subsection (d) (as redesignated by para-
14 graph (1))—

15 (A) in paragraph (1), by striking “(1) The
16 Secretary” and inserting the following:

17 “(1) IN GENERAL.—The Secretary”;

18 (B) in paragraph (2), by striking “(2) The
19 Secretary” and inserting the following:

20 “(3) COORDINATION.—The Secretary”; and

21 (C) by inserting after paragraph (1) the
22 following:

23 “(2) COOPERATIVE AGREEMENTS FOR THE
24 PRESERVATION AND INTERPRETATION OF CERTAIN
25 PROPERTIES.—

1 “(A) IN GENERAL.—The Secretary may
2 enter into cooperative agreements with the own-
3 ers of the 7 residences referred to in subsection
4 (b) pursuant to which the Secretary may use
5 appropriated funds to mark, interpret, improve,
6 restore, and provide technical assistance with
7 respect to the preservation and interpretation of
8 the properties.

9 “(B) INCLUSIONS.—An agreement entered
10 into under subparagraph (A) shall include a
11 provision specifying that no changes or alter-
12 ations shall be made to the exterior of the prop-
13 erties subject to the agreement, except by the
14 mutual agreement of the parties to the agree-
15 ment.”.
