A BILL

- To amend the Help America Vote Act of 2002 to allow all eligible voters to vote by mail in Federal elections, to amend the National Voter Registration Act of 1993 to provide for automatic voter registration, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Vote at Home Act of3 2023".

4 SEC. 2. FINDINGS.

5 Congress finds the following:

6 (1) An inequity of voting rights exists in the
7 United States because voters in some States have
8 the universal right to vote by mail while voters in
9 other States do not.

10 (2) Many voters often have work, family, or 11 other commitments that make getting to polls and waiting in line on the date of an election difficult or 12 13 impossible. Many citizens with disabilities are phys-14 ically unable to vote due to long lines, inadequate 15 parking, no curb cuts, steep ramps, and large 16 crowds. In 2012, 30 percent of voters with disabil-17 ities had difficulty voting, and in 2016, nearly two-18 thirds of the 137 polling places inspected on Elec-19 tion Day had at least one impediment to people with 20 disabilities. However, with expanded access to mail-21 in ballots, people with disabilities made large gains 22 in 2020 with a historic voter turnout surge.

(3) In 2020, despite a global pandemic, the
general election saw record high turnout as a result
of increased vote by mail options, which allowed voters to cast a ballot and stay safe at the same time.

1	(4) 34 States and the District of Columbia cur-
2	rently allow universal absentee voting (also known as
3	"no-excuse" absentee voting), which permits any
4	voter to request a mail-in ballot without providing a
5	reason for the request. No State which has imple-
6	mented no-excuse absentee voting has repealed it.
7	(5) 5 States currently hold elections entirely by
8	mail. 8 States proactively send all registered voters
9	a ballot to be submitted by mail or dropped off at
10	a designated location. At least 22 States currently
11	allow some elections to be conducted by mail, espe-
12	cially in large and rural jurisdictions where voting by
13	mail is especially convenient. Polling stations in
14	rural jurisdictions tend to have higher costs per
15	voter, smaller staffs, and limited resources. Trans-
16	portation is often a crucial barrier for rural voters.
17	(6) In 2020, in order to provide greater accessi-
18	bility and to protect the public health, 30 States
19	adopted or changed their laws for the general elec-
20	tion to allow voters to cast their ballots from home.
21	These changes included removing strict excuse re-
22	quirements or allowing COVID–19 concerns to be a
23	valid excuse to vote absentee, allowing ballot drop
24	boxes, offering prepaid postage on election mail and
25	proactively sending all active registered voters appli-

cations to request an absentee ballot, with some even skipping that step and sending the actual ballots.

3 (7) Voting by mail gives voters more time to
4 consider their choices, which is especially important
5 as many ballots contain greater numbers of ques6 tions about complex issues than in the past due to
7 the expanded use of the initiative and referendum
8 process in many States.

9 (8) Voting by mail is cost effective. After the 10 State of Oregon adopted vote by mail for all voters 11 in 1996, the cost to administer an election in the 12 State dropped by nearly 30 percent over the next 13 few elections, from \$3.07 per voter to \$2.21 per 14 voter. After Colorado implemented all-mail balloting 15 in 2013, voting administration costs decreased by an 16 average of 40 percent. The cost of conducting vote-17 by-mail elections is generally one-third to one-half 18 less than conducting polling place elections. Voting 19 by mail also saves a substantial amount by getting 20 rid of the temporary labor costs of hiring poll work-21 ers. In addition to that cost, many jurisdictions have 22 been facing difficulty in obtaining sufficient numbers 23 of poll workers.

24 (9) Allowing all voters the option to vote by25 mail can reduce waiting times for those voters who

choose to vote at the polls. In 2016, voters in Ari zona reported waiting in line from 1 to 5 hours to
 vote; in New York, voters reported that stations ran
 out of ballots and did not have staff during all of
 the hours scheduled for voting.

6 (10) Voting by mail is preferable to many vot-7 ers as an alternative to going to the polls. In 2020, 8 43.2 percent of ballots in the United States were 9 cast by mail, up from 10 percent in 2000. Voting by 10 mail has become increasingly popular with voters 11 who want to be certain that they are able to vote no 12 matter what comes up on Election Day, as it re-13 duces the physical obstacles and eases the time con-14 straints connected with the act of voting.

15 (11) Despite attempts to claim that voting by 16 mail is susceptible to fraud, it is not. Strategies such 17 as the tracking systems for ballots and Postal Serv-18 ice cooperation in preventing ballots from being de-19 livered to names not recognized as receiving mail at 20 an address nearly eliminate the potential for fraud 21 in vote by mail elections. Evidence of undue influ-22 ence or voter coercion after vote-by-mail implementa-23 tion in Oregon has been nonexistent to minimal.

24 (12) Many of the reasons which voters in many25 States are required to provide in order to vote by

mail require the revelation of personal information about health, travel plans, or religious activities,

which violate voters' privacy while doing nothing toprevent voter fraud.

5 (13) State laws which require voters to obtain
6 a notary signature to vote by mail only add cost and
7 inconvenience to voters without increasing security.

8 (14) Many voters choose to cast ballots early 9 when they have the option (over 50 percent in Ari-10 zona, Arkansas, California, Colorado, Florida, Geor-11 gia, Hawaii, Montana, Nevada, New Mexico, North 12 Carolina, Oregon, Tennessee, Texas, Utah, and 13 Washington). Approximately 70 percent of voters in 14 the 2020 election cast their ballot before Election 15 Day. In Oregon, 7 years after vote-by-mail election 16 implementation, over 80 percent of voters favored 17 the vote-by-mail system.

18 (15) Vote-by-mail typically increases turnout in 19 all elections, but can be particularly effective in in-20 creasing voter participation in special elections and 21 primary elections. Oregon, Washington, and Colo-22 rado, 3 of the 5 States with entirely vote by mail 23 systems, continue to have consistently high voter 24 turnout rates. In 2020, the Presidential election 25 turnout was about 7 percentage points higher than

in 2016, and turnout rates increased in every State
compared with 2016. In the 10 States where it rose
the most, 7 conducted their vote entirely or mostly
by mail, with 6 of those States having recently
adopted all-mail voting, either permanently (Utah
and Hawaii) or for the 2020 elections only.
(16) A crucial component of a modern voting

8 system is making it easy, affordable, and accessible 9 to register to vote. Twenty-two states and the Dis-10 trict of Columbia have enacted automatic voter reg-11 istration policies, with Oregon and California becom-12 ing the first to automatically register their citizens 13 to vote when they apply for a driver's license. Auto-14 matic, permanent voter registration has the potential 15 to increase participation, protect election integrity, 16 and reduce registration costs.

17 SEC. 3. PROMOTING ABILITY OF VOTERS TO VOTE BY MAIL

IN FEDERAL ELECTIONS.

19 (a) VOTING BY MAIL IN FEDERAL ELECTIONS.—

20 (1) IN GENERAL.—Subtitle A of title III of the
21 Help America Vote Act of 2002 (52 U.S.C. 21081
22 et seq.) is amended by inserting after section 303
23 the following new section:

3 "(a) IN GENERAL.—If an individual in a State is eligible to cast a vote in an election for Federal office, the 4 5 State may not impose any additional conditions or requirements on the eligibility of the individual to cast the vote 6 7 in such election by mail, except to the extent that the 8 State imposes a deadline for requesting the ballot and re-9 lated voting materials from the appropriate State or local 10 election official and for returning the ballot to the appro-11 priate State or local election official.

12 "(b) PROVISION OF BALLOT MATERIALS.—Not later
13 than 2 weeks before the date of any election for Federal
14 office, each State shall mail ballots to individuals who are
15 registered to vote in such election.

16 "(c) ACCESSIBILITY FOR INDIVIDUALS WITH DIS-17 ABILITIES.—All ballots provided under this section shall 18 be accessible to individuals with disabilities in a manner 19 that provides the same opportunity for access and partici-20 pation (including for privacy and independence) as for 21 other voters.

"(d) RULE OF CONSTRUCTION.—Nothing in this section shall be construed to affect the authority of States
to conduct elections for Federal office through the use of
polling places at which individuals cast ballots.

"(e) EFFECTIVE DATE.—A State shall be required
 to comply with the requirements of this section with re spect to elections for Federal office held in years beginning
 with 2024.".

12 (b) FREE POSTAGE FOR VOTING BY MAIL.—

13 (1) IN GENERAL.—Chapter 34 of title 39,

15 end the following:

16 "§3407. Ballots provided for voting in Federal elec17 tions

18 "Blank ballots mailed pursuant to section 303A(b)
19 of the Help America Vote Act of 2002 which are mailed
20 by a State or local election official (individually or in bulk)
21 to a voter, and voted ballots which are mailed by a voter
22 to an election official, shall be carried expeditiously and
23 free of postage.".

20	"(B) ELIGIBLE INDIVIDUALS REGISTERED
21	AT A DIFFERENT ADDRESS.—In the case of an
22	applicable individual who is eligible to vote in
23	an election for Federal office and who is reg-
24	istered to vote in such election at a different
25	address than the address provided in the identi-

1	fying information, the appropriate State elec-
2	tion official shall issue a notification to the indi-
3	vidual containing—
4	"(i) a statement that, unless the indi-
5	vidual notifies the election official prior to
6	the expiration of the 21-calendar day pe-
7	riod which begins on the date the official
8	issued the notification that the address
9	provided in the identifying information
10	should not be used for voter registration
11	purposes, the address provided in the iden-
12	tifying information shall be used as the in-
13	dividual's address for voter registration
14	purposes; and
15	"(ii) a description of the process by
16	which the individual may decline a change
17	of address for voter registration purposes.
18	"(c) Automatic Registration of Eligible Indi-
19	VIDUALS; AUTOMATIC CHANGE OF ADDRESS.—
20	"(1) REGISTRATION.—Upon the expiration of
21	the 21-calendar day period which begins on the date
22	the appropriate State election official issues a notifi-
23	cation to an individual under subsection $(b)(2)(A)$,
24	the official shall ensure that the individual is reg-

1	istered to vote in elections for Federal office held in
2	the State unless—
3	"(A) the official later determines that the
4	individual does not meet the eligibility require-
5	ments for registering to vote in such elections;
6	or
7	"(B) prior to the expiration of such 21-cal-
8	endar day period, the individual notifies the of-
9	ficial that the individual declines to be reg-
10	istered to vote in such elections.
11	"(2) Change of address.—Upon the expira-
12	tion of the 21-calendar day period which begins on
13	the date the appropriate State election official issues
14	a notification to an individual under subsection
15	(b)(2)(B), the official shall ensure that the indi-
16	vidual is registered to vote in elections for Federal
17	office at the address provided in the identifying in-
18	formation unless—
19	"(A) the official later determines that the
20	individual does not meet the eligibility require-
21	ments for registering to vote in such elections;
22	OF
23	"(B) prior to the expiration of such 21-cal-
24	endar day period, the individual notifies the of-

ficial that the individual declines a change of address for voter registration purposes.

3 "(d) APPLICABLE INDIVIDUAL.—For purposes of this
4 section, the term 'applicable individual' means any indi5 vidual who seeks assistance from, receives benefits from,
6 or receives service or assistance from a State motor vehicle
7 authority that issues motor vehicle driver's licenses.".

(d) EFFECTIVE DATE.—The amendments made by
 this section shall take effect upon the expiration of the
 180-day period which begins on the date of the enactment
 of this Act.
