## A BILL

To amend the Federal Fire Prevention and Control Act of 1974 to authorize appropriations for the United States Fire Administration and firefighter assistance grant programs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fire Grants and Safety  
5 Act”.

1 **SEC. 2. REAUTHORIZATION OF THE UNITED STATES FIRE**  
2 **ADMINISTRATION.**

3 Section 17(g)(1) of the Federal Fire Prevention and  
4 Control Act of 1974 (15 U.S.C. 2216(g)(1)) is amended—

5 (1) in subparagraph (L), by striking “and”;

6 (2) in subparagraph (M), by striking the period  
7 and inserting “; and”; and

8 (3) by adding at the end the following:

9 “(N) \$95,000,000 for each of fiscal years 2024  
10 through 2030, of which \$3,420,000 for each such  
11 fiscal year shall be used to carry out section 8(f).”.

12 **SEC. 3. REAUTHORIZATION OF ASSISTANCE TO FIRE-**  
13 **FIGHTERS GRANTS PROGRAM AND THE FIRE**  
14 **PREVENTION AND SAFETY GRANTS PRO-**  
15 **GRAM.**

16 (a) **REPEAL OF SUNSET.**—Section 33(r) of the Fed-  
17 eral Fire Prevention and Control Act of 1974 (15 U.S.C.  
18 2229(r)) is amended by striking “2024” and inserting  
19 “2032”.

20 (b) **AUTHORIZATION OF APPROPRIATIONS.**—Section  
21 33(q)(1)(B) of the Federal Fire Prevention and Control  
22 Act of 1974 (15 U.S.C. 2229(q)(1)(B)) is amended, in the  
23 matter preceding clause (i), by striking “2023” and insert-  
24 ing “2030”.

1 **SEC. 4. REAUTHORIZATION OF STAFFING FOR ADEQUATE**  
2 **FIRE AND EMERGENCY RESPONSE GRANT**  
3 **PROGRAM.**

4 (a) **REPEAL OF SUNSET.**—Section 34(k) of the Fed-  
5 eral Fire Prevention and Control Act of 1974 (15 U.S.C.  
6 2229a(k)) is amended by striking “2024” and inserting  
7 “2032”.

8 (b) **AUTHORIZATION OF APPROPRIATIONS.**—Section  
9 34(j)(1)(I) of the Federal Fire Prevention and Control Act  
10 of 1974 (15 U.S.C. 2229a(j)(1)(I)) is amended, in the  
11 matter preceding clause (i), by striking “2023” and insert-  
12 ing “2030”.
