### **3** SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Mill Springs Battle-
- 5 field National Monument Act".

#### 6 SEC. 2. DEFINITIONS.

3	(3) NOTICE.—Not later than 30 days after the
4	date on which the Secretary makes a determination
5	under paragraph (2), the Secretary shall publish in
6	the Federal Register notice of the establishment of
7	the Monument.
8	(4) BOUNDARY.—The boundary of the Monu-
9	ment shall be as generally depicted on the Map.
10	(5) AVAILABILITY OF MAP.—The Map shall be
11	on file and available for public inspection in the ap-
12	propriate offices of the National Park Service.
13	(6) Acquisition Authority.—The Secretary
14	may only acquire land or an interest in land located
15	within the boundary of the Monument by—
16	(A) donation;
17	(B) purchase with donated funds; or
18	(C) exchange.
19	(b) Administration.—
20	(1) IN GENERAL.—The Secretary shall admin-
21	ister the Monument in accordance with—
22	(A) this Act; and
23	(B) the laws generally applicable to units

7	(2) MANAGEMENT PLAN.—
8	(A) IN GENERAL.—Not later than 3 years
9	after the date on which funds are first made
10	available to prepare a general management plan
11	for the Monument, the Secretary shall prepare
12	the general management plan in accordance
13	with section 100502 of title 54, United States
14	Code.
15	(B) SUBMISSION TO CONGRESS.—On com-
16	pletion of the general management plan, the
17	Secretary shall submit to the Committee on
18	Natural Resources of the House of Representa-
19	tives and the Committee on Energy and Nat-
20	ural Resources of the Senate the general man-
21	agement plan.
22	(c) PRIVATE PROPERTY PROTECTION.—Nothing in
23	this Act affects the land use rights of private property
24	owners within or adjacent to the Monument.
25	(d) NO BUFFER ZONES.—

(1) IN GENERAL.—Nothing in this Act, the es tablishment of the Monument, or the management of
 the Monument creates a buffer zone outside the
 Monument.

5 (2) ACTIVITY OR USE OUTSIDE MONUMENT.—
6 The fact that an activity or use can be seen, heard,
7 or detected from within the Monument shall not pre8 clude the conduct of the activity or use outside the
9 Monument.
