A BILL

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Improving HOPE for
- 5 Alzheimer's".

1 SEC. 2. CENTERS FOR MEDICARE AND MEDICAID SERVICES 2 PROVIDER OUTREACH AND REPORTING ON 3 COMPREHENSIVE ALZHEIMER'S DISEASE 4 CARE PLANNING SERVICES.

5 (a) OUTREACH.—The Secretary of Health and Human Services (in this section referred to as the "Sec-6 7 retary") shall conduct outreach to physicians and appro-8 priate non-physician practitioners participating under the 9 Medicare program under title XVIII of the Social Security Act (42 U.S.C. 1395 et seq.) with respect to comprehen-10 11 sive care planning services furnished to individuals with Alzheimer's disease and related dementias (in this section 12 referred to as "comprehensive Alzheimer's disease care 13 planning services"). Such outreach shall include a com-14 prehensive, one-time education initiative to inform such 15 16 physicians and practitioners of the addition of such services as a covered benefit under the Medicare program, in-17 18 cluding materials on appropriate diagnostic evaluations 19 and explanations of the requirements for eligibility for 20such services.

21 (b) Reports to Congress.—

(1) PROVIDER OUTREACH.—Not later than one
year after the date of enactment of this Act, the
Secretary shall submit to the Committee on Ways
and Means and the Committee on Energy and Commerce of the House of Representatives and the Com•HR 1873 IH

mittee on Finance of the Senate a report on the out reach conducted under subsection (a). Such report
 shall include a description of the methods used for
 such outreach.

(2) UTILIZATION RATES.—Not later than 18 5 6 months after such date of enactment and annually 7 thereafter for the succeeding five years, the Sec-8 retary shall submit to the Committee on Ways and 9 Means and the Committee on Energy and Commerce 10 of the House of Representatives and the Committee 11 on Finance of the Senate a report on the number of 12 Medicare beneficiaries who, during the preceding 13 year, were furnished comprehensive Alzheimer's dis-14 ease care planning services for which payment was 15 made under title XVIII of the Social Security Act 16 (42 U.S.C. 1395 et seq.). Each such report shall in-17 clude information on any barriers Medicare bene-18 ficiaries face to access such services and the rec-19 ommendations of the Secretary to eliminate any 20 such barriers.

(3) COPY OF EACH REPORT.—On the same day
that a report is submitted under paragraph (1) or
(2), the Secretary shall transmit a copy of such report to the Advisory Council on Alzheimer's Research, Care, and Services established under section

- 1 2(e) of the National Alzheimer's Project Act (42
- 2 U.S.C. 11225(e); Public Law 111–375).
