1 AN ACT concerning

2 **Carroll County – Alcoholic Beverages – Hours and Days for Consumption and**
3 **Sale**

4 FOR the purpose of altering the hours and days for consumption and sale, in Carroll
5 County, for certain alcoholic beverages licenses; and generally relating to alcoholic
6 beverages in Carroll County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages**

20 16–102.

21 This title applies only in Carroll County.

23 (a) A holder of a Class A beer license may sell or provide beer on Monday through

2 (b) A holder of a Class B beer license may sell or provide beer on Monday through
3 Saturday, from 8 a.m. to [1] 2 a.m. the following day.

4 (c) A holder of a Class C beer license may sell or provide beer on Monday through
5 Saturday from 8 a.m. to [1] 2 a.m. the following day.

6 (d) A holder of a Class D beer license may sell or provide beer on Monday through
7 Saturday from 8 a.m. to [1] 2 a.m. the following day.

9 (a) A holder of a Class A beer and wine license may sell or provide beer and wine
10 on Monday through Sunday from 8 a.m. to 11 p.m.

11 (b) (1) A holder of a 6–day Class B beer and wine license may sell or provide
12 beer and wine for on–premises consumption on Monday through Saturday from 8 a.m. to
13 [1] 2 a.m. the following day.

14 (2) A holder of a 7–day Class B beer and wine license may sell or provide
15 beer and wine for on–premises consumption:

16 (I) on Monday through **SATURDAY FROM 8 A.M. TO 2 A.M. THE**
17 **FOLLOWING DAY; AND**

18 (II) **ON** Sunday from 8 a.m. to 1 a.m. the following day.

19 (3) A holder of a 7–day Class B beer and wine license may sell beer and
20 wine for off–premises consumption on Monday through Sunday from 8 a.m. to 11 p.m.

21 (c) A holder of a Class C beer and wine license may sell or provide beer and wine
22 on Monday through Saturday from 8 a.m. to [1] 2 a.m. the following day.

23 (d) (1) A holder of a 6–day or 7–day Class D beer and wine license may sell or
24 provide beer and wine on Monday through Saturday from [6] 8 a.m. to [midnight] 2 A.M.
25 **THE FOLLOWING DAY.**

26 (2) A holder of a 7–day Class D beer and wine license may sell or provide
27 beer and wine on Sunday from 8 a.m. to [11 p.m.] 1 A.M. **THE FOLLOWING DAY.**

28 16–2005.

29 (a) A holder of a Class A beer, wine, and liquor license may sell or provide beer,
30 wine, and liquor on Monday through Sunday from 8 a.m. to 11 p.m.

(b) A holder of a Class B beer, wine, and liquor license may sell or provide beer, wine, and liquor:

(1) on Monday through [Sunday] SATURDAY from 8 a.m. to [1] 2 a.m. the following day; AND

(2) ON SUNDAY FROM 8 A.M. TO 1 A.M. THE FOLLOWING DAY.

(c) A holder of a Class C beer, wine, and liquor license may sell or provide beer, wine, and liquor:

(1) on Monday through [Sunday] SATURDAY from 8 a.m. to [1] 2 a.m. the following day; AND

(2) ON SUNDAY FROM 8 A.M. TO 1 A.M. THE FOLLOWING DAY.

(d) Reserved.

(e) A holder of a Class H beer, wine, and liquor license may sell or provide beer, wine, and liquor:

(1) on Monday through [Sunday] SATURDAY from 8 a.m. to [1] 2 a.m. the following day; AND

(2) ON SUNDAY FROM 8 A.M. TO 1 A.M. THE FOLLOWING DAY.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2020.
