A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Registration – Fee Due to Outstanding Warrant – Repeal**

3 FOR the purpose of repealing a certain fee required to be assessed by the Motor Vehicle
4 Administration against an applicant for registration of a motor vehicle who had
5 previously been refused due to an outstanding warrant; and generally relating to
6 vehicle registration and outstanding warrants.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

24 **Article – Transportation**

2 (b) Subject to subsection (h) of this section, on notification by a law enforcement
3 agency that an applicant for vehicle registration is named in an outstanding warrant, the
4 Administration shall refuse to register or transfer the registration of any vehicle owned by
5 the applicant.

6 (f) (1) The Administration shall continue the refusal to register or transfer the
7 registration of a vehicle owned by an individual named in an outstanding warrant until:

8 (i) The Administration is ordered by a court to register or transfer
9 the registration of the vehicle; or

10 (ii) A law enforcement agency notifies the Administration that:

11 1. The individual named in the outstanding warrant has
12 been arrested; or

13 2. The outstanding warrant has been otherwise satisfied.

14 (2) On receipt of an order or notice under paragraph (1) of this subsection,
15 the Administration shall allow the applicant to register the vehicle or transfer the
16 registration unless the registration or transfer has been restricted under any other
17 provision of the Maryland Vehicle Law.

18 [(i) (1) In addition to any other fee or penalty provided by law, the owner of a
19 vehicle refused registration under this section shall pay a fee established by the
20 Administration before renewal of the registration of the vehicle.

21 (2) The fee under paragraph (1) of this subsection shall be retained by the
22 Administration and may not be credited to the Gasoline and Motor Vehicle Revenue
23 Account for distribution under § 8-403 or § 8-404 of this article.]

24 [(j) (I) The procedures specified in this section are in addition to any other
25 penalty provided by law for the failure to meet the demands specified in a warrant.

26 [(k) (J) This section may not be construed to require the Administration to
27 arrest a person named in an outstanding warrant.

28 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
29 October 1, 2024.
