A BILL TO BE ENTITLED AN ACT

1 To amend an Act incorporating the City of McDonough, approved April 16, 1981 2 (Ga. L. 1981, p. 3387), as amended, particularly by an Act approved April 12, 2012 3 (Ga. L. 2012, p. 5452), so as to revise the corporate boundaries of the municipality; to 4 provide for related matters; to provide for a referendum and contingent effective dates; to 5 repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

8 An Act incorporating the City of McDonough, approved April 16, 1981 (Ga. L. 1981,

9 p. 3387), as amended, particularly by an Act approved April 12, 2012 (Ga. L. 2012, p. 5452),

10 is amended by adding a new subsection to Section 1.11 to read as follows:

- 11 "(c) In addition to all areas presently within the corporate boundaries of the City of
- 12 McDonough, the corporate boundaries shall include the following described territory:

For the purposes of this description, the term "VTD" shall mean and describe the same geographical boundaries as provided in the report of the Bureau of the Census for the United States decennial census of 2010 for the State of Georgia. The separate numeric designations in the description which are underneath a VTD heading shall mean and describe individual blocks within a VTD as provided in the report of the Bureau of the Census for the United States decennial census of 2010 for the State of Georgia.

SECTION 2.

45 The election superintendent of Henry County shall call and conduct an election as provided 46 in this section for the purpose of submitting this Act to the electors of the territory sought to 47 be annexed into the City of McDonough under this Act for approval or rejection. The 48 election superintendent shall conduct such election on the date of and in conjunction with 49 the 2018 November General Election and shall issue the call and conduct such election as 50 provided by general law. The election superintendent shall cause the date and purpose of the 51 election to be published once a week for two weeks immediately preceding the date thereof 52 in the official organ of Henry County. The ballot shall have written or printed thereon the 53 words:

54 "() YES Shall the Act be approved which annexes certain land into the City of
55 () NO McDonough?"

All persons desiring to vote for approval of the annexation shall vote "Yes" and all persons desiring to vote for rejection of the annexation shall vote "No." If more than one-half of the votes cast on such question are for approval of the annexation, then this Act shall become effective on January 1, 2019. If more than one-half of the votes cast on such question are for

- 60 rejection of the annexation or if the election is not held as provided in this section, then this
- 61 Act shall not become effective and shall automatically be repealed on January 1, 2019. The
- 62 expense of such election shall be borne by the City of McDonough. It shall be the election
- 63 superintendent's duty to certify the result thereof to the Secretary of State.

64 SECTION 3.

- 65 Except as provided in Section 2 of this Act, this Act shall become effective upon its approval
- 66 by the Governor or upon its becoming law without such approval.

SECTION 4.

68 All laws and parts of laws in conflict with this Act are repealed.
