

In the Senate of the United States,

September 18, 2018.

Resolved, That the bill from the House of Representatives (H.R. 46) entitled “An Act to authorize the Secretary of the Interior to conduct a special resource study of Fort Ontario in the State of New York.”, do pass with the following

AMENDMENT:

Strike out all after the enacting clause and insert:

1 ***SECTION 1. SHORT TITLE.***

2 *This Act may be cited as the “Fort Ontario Study*
3 *Act”.*

4 ***SEC. 2. DEFINITIONS.***

5 *In this Act:*

6 (1) *SECRETARY.*—*The term “Secretary” means*
7 *the Secretary of the Interior.*

8 (2) *STUDY AREA.*—*The term “study area” means*
9 *Fort Ontario in Oswego, New York.*

1 **SEC. 3. FORT ONTARIO SPECIAL RESOURCE STUDY.**

2 (a) *IN GENERAL.*—*The Secretary shall conduct a spe-*
3 *cial resource study of the study area.*

4 (b) *CONTENTS.*—*In conducting the study under sub-*
5 *section (a), the Secretary shall—*

6 (1) *evaluate the national significance of the*
7 *study area;*

8 (2) *determine the suitability and feasibility of*
9 *designating the study area as a unit of the National*
10 *Park System;*

11 (3) *consider other alternatives for preservation,*
12 *protection, and interpretation of the study area by the*
13 *Federal Government, State or local government enti-*
14 *ties, or private and nonprofit organizations;*

15 (4) *consult with interested Federal agencies,*
16 *State or local governmental entities, private and non-*
17 *profit organizations, or any other interested individ-*
18 *uals; and*

19 (5) *identify cost estimates for any Federal acqui-*
20 *sition, development, interpretation, operation, and*
21 *maintenance associated with the alternatives.*

22 (c) *APPLICABLE LAW.*—*The study required under sub-*
23 *section (a) shall be conducted in accordance with section*
24 *100507 of title 54, United States Code.*

25 (d) *REPORT.*—*Not later than 3 years after the date*
26 *on which funds are first made available to carry out the*

1 *study under subsection (a), the Secretary shall submit to*
2 *the Committee on Natural Resources of the House of Rep-*
3 *resentatives and the Committee on Energy and Natural Re-*
4 *sources of the Senate a report that describes—*

5 *(1) the results of the study; and*

6 *(2) any conclusions and recommendations of the*
7 *Secretary.*
