## **A BILL**

To amend title 38, United States Code, to authorize the Secretary of Veterans Affairs to provide for an operation on a live donor for purposes of conducting a transplant procedure for a veteran, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Veterans Transplant*  
5 *Coverage Act of 2017”.*

6 **SEC. 2. AUTHORIZATION TO PROVIDE FOR OPERATIONS ON**  
7 **LIVE DONORS FOR PURPOSES OF CON-**  
8 **DUCTING TRANSPLANT PROCEDURES FOR**  
9 **VETERANS.**

10 *(a) IN GENERAL.—Subchapter VIII of chapter 17 of*  
11 *title 38, United States Code, is amended by adding at the*  
12 *end the following new section:*

13 **“§ 1788. Transplant procedures with live donors and**  
14 **related services**

15 *“(a) IN GENERAL.—In a case in which a veteran is*  
16 *eligible for a transplant procedure from the Department,*  
17 *the Secretary may provide for an operation on a live donor*  
18 *to carry out such procedure for such veteran, notwith-*  
19 *standing that the live donor may not be eligible for health*  
20 *care from the Department.*

21 *“(b) OTHER SERVICES.—Subject to the availability of*  
22 *appropriations for such purpose, the Secretary shall furnish*  
23 *to a live donor any care or services before and after con-*  
24 *ducting the transplant procedure under subsection (a) that*  
25 *may be required in connection with such procedure.*

1           “(c) *USE OF DEPARTMENT OR NON-DEPARTMENT FA-*  
2 *CILITIES.*—*The Secretary may provide for the operation de-*  
3 *scribed in subsection (a) on a live donor and furnish to*  
4 *the live donor the care and services described in subsection*  
5 *(b) at a facility of the Department or at a non-Department*  
6 *facility pursuant to an agreement entered into by the Sec-*  
7 *retary under section 1703 or 8153 of this title, section 101*  
8 *of the Veterans Access, Choice, and Accountability Act of*  
9 *2014 (Public Law 113–146; 38 U.S.C. 1701 note), or any*  
10 *other authority of the Secretary to furnish care at non-De-*  
11 *partment facilities. The live donor shall be deemed to be*  
12 *an individual eligible for hospital care and medical services*  
13 *at a non-Department facility pursuant to such an agree-*  
14 *ment solely for the purposes of receiving such operation,*  
15 *care, and services at the non-Department facility.”.*

16           (b) *CLERICAL AMENDMENT.*—*The table of sections at*  
17 *the beginning of chapter 17 of such title is amended by in-*  
18 *serting after the item relating to section 1787 the following*  
19 *new item:*

“1788. *Transplant procedures with live donors and related services.*”.
