A BILL

To increase the ability of nursing facilities to access telehealth services and obtain technologies to allow virtual visits during the public health emergency relating to an outbreak of coronavirus disease 2019 (COVID-19), and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

- This Act may be cited as the "Advancing"
- 3 Connectivity during the Coronavirus to Ensure Support
- 4 for Seniors Act" or the "ACCESS Act".

- 7 SEC. 101. SUPPLEMENTAL APPROPRIATIONS.
- 8 The following sums are hereby appropriated, out of
- 9 any money in the Treasury not otherwise appropriated,
- 10 for the fiscal year ending September 30, 2020, and for
- 11 other purposes, namely:
- 12 DEPARTMENT OF HEALTH AND HUMAN
- 13 SERVICES
- 14 HEALTH RESOURCES AND SERVICES ADMINISTRATION
- 15 RURAL HEALTH
- For an additional amount for the Telehealth Re-
- 17 source Center of the Federal Office of Rural Health Policy
- 18 of the Office for the Advancement of Telehealth, to pro-
- 19 vide assistance with respect to technical, legal, regulatory
- 20 service delivery or other related barriers to the develop-
- 21 ment of telehealth technologies for skilled nursing facilities
- 22 (as defined in section 1819 of the Social Security Act) and
- 23 nursing facilities (as defined in section 1919 of such Act),
- 24 \$50,000,000 to remain available through September 30,
- 25 2021.

- 3 SEC. 203. AUTHORITY TO AWARD GRANTS TO NURSING FA-
- 4 CILITIES FOR SUPPORTING VIRTUAL VISITS
- 5 DURING THE COVID-19 PUBLIC HEALTH
- 6 EMERGENCY.
- 7 (a) IN GENERAL.—The Secretary shall award grants
- 8 directly to skilled nursing facilities and nursing facilities
- 9 in accordance with this section to support virtual visits
- 10 by family members and other individuals for residents of
- 11 such facilities during the COVID-19 public health emer-
- 12 gency period.
- 13 (b) Coordination.—The Secretary shall coordinate
- 14 with the Federal Communications Commission to ensure
- 15 that all facilities awarded a grant under this section are
- 16 able to carry out the purposes described in subsection (d),
- 17 including through the provision of telecommunications and
- 18 broadband services necessary to support virtual visits de-
- 19 scribed in subsection (a).
- 20 (c) Application Requirements.—A facility seek-
- 21 ing a grant under this section shall submit an application
- 22 to the Secretary at such time, in such form and manner,
- 23 and containing such information as the Secretary shall re-
- 24 quire.

- 1 (d) USE OF FUNDS.—A facility awarded a grant 2 under this section may only use the funds for expenditures
- 3 attributable to obtaining and using—
- 4 (1) technologies to support virtual visits de-5 scribed in subsection (a); and
- 6 (2) any other items or services necessary to carry out such visits.

- (1) TERMINATION OF AUTHORITY.—The Secretary shall not award any grants under this section after the end of the COVID-19 public health emergency period.
- 13 (2) SUPPLEMENT, NOT SUPPLANT.—Federal
 14 funds paid to a skilled nursing facility or a nursing
 15 facility pursuant to this section must be used to sup16 plement, but not supplant, any other Federal, State,
 17 or local funds available to the facility that may be
 18 used for a purpose specified in subsection (d).
- (f) GUIDANCE.—Not later than 15 days after the date of the enactment of this Act, the Secretary shall issue guidance on steps facilities awarded grants under this section shall take to ensure residents of such facilities have access to virtual visitation during the COVID-19 public health emergency period and how such access shall be fa-

- 1 tions for how such facilities will ensure notification of resi-
- 2 dents and resident representatives of such virtual visita-
- 3 tion access and facilitation, address how adequate support
- 4 will be provided to residents to facilitate virtual visitation,
- 5 address how facilities will ensure or enable installation and
- 6 access to a device purchased for the use or benefit of indi-
- 7 vidual or multiple facility residents, and address oper-
- 8 ational issues and avoid unnecessary barriers to timely de-
- 9 ployment of virtual visitation.
- 10 (g) Report.—Not later than 30 days after the end
- 11 of the COVID-19 public health emergency period, the Sec-
- 12 retary shall submit a report to Congress on the grants
- 13 awarded under this section.
- 14 (h) APPROPRIATION.—There are appropriated to the
- 15 Secretary for fiscal year 2020, from any funds in the
- 16 Treasury not otherwise appropriated, such sums as are
- 17 necessary to carry out this section, to remain available
- 18 through the last day of the month following the month
- 19 in which the COVID-19 public health emergency period
- 20 ends.

21 TITLE III—MISCELLANEOUS

- 22 SEC. 301. EMERGENCY DESIGNATION.
- (a) In General.—The amounts provided by this Act
- 24 are designated as an emergency requirement pursuant to

- 1 section 4(g) of the Statutory Pay-As-You-Go Act of 2010
- 2 (2 U.S.C. 933(g)).
- 3 (b) Designation in Senate.—In the Senate, this
- 4 Act is designated as an emergency requirement pursuant
- 5 to section 4112(a) of H. Con. Res. 71 (115th Congress),
- 6 the concurrent resolution on the budget for fiscal year
- 7 2018.
