A BILL

To amend titles 10 and 38, United States Code, to expand certain benefits for survivors of members of the Armed Forces who die in line of duty, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "SFC Brian Woods
- 5 Gold Star and Military Survivors Act".

1	SEC. 2. EXTENSION OF COMMISSARY AND EXCHANGE BEN-
2	EFITS FOR REMARRIED SPOUSES WITH DE-
3	PENDENT CHILDREN.
4	(a) Benefits.—Section 1062 of title 10, United
5	States Code, is amended—
6	(1) by striking "The Secretary" and all that
7	follows through "an" and inserting "(a) CERTAIN
8	Unremarried Former Spouses.—An";
9	(2) by striking "commissary and exchange
10	privileges" and inserting "use commissary stores
11	and MWR retail facilities"; and
12	(3) by adding at the end the following new sub-
13	sections:
14	"(b) Certain Remarried Surviving Spouses.—A
15	surviving spouse of a deceased member of the armed
16	forces, regardless of the marital status of the surviving
17	spouse, who has guardianship of dependent children of the
18	deceased member, is entitled to use commissary stores and
19	MWR retail facilities to the same extent and on the same
20	basis as the unremarried surviving spouse of a member
21	of the uniformed services.
22	"(c) MWR RETAIL FACILITIES.—The term 'MWR
23	retail facilities' has the meaning given that term in section
24	1063(e) of this title.".

5	SEC. 4. AUTHORITY OF THE SECRETARY CONCERNED TO
6	TRANSPORT REMAINS OF A COVERED DECE-
7	DENT TO NO MORE THAN TWO LOCATIONS
8	SELECTED BY THE PERSON DESIGNATED TO
9	DIRECT DISPOSITION OF THE REMAINS.
10	(a) In General.—Section 1482(a)(8) of title 10,
11	United States Code, is amended to read as follows:
12	"(8)(A) Transportation of the remains, and
13	travel and transportation allowances as specified in
14	regulations prescribed under section 464 of title 37
15	for an escort of one person, to the place, subject to
16	subparagraph (B), selected by the person designated
17	to direct disposition of the remains or, if such a se-
18	lection is not made, to a national or other cemetery
19	which is selected by the Secretary and in which bur-
20	ial of the decedent is authorized.
21	"(B) The person designated to direct disposi-
22	tion of the remains may select two locations under
23	subparagraph (A) if the second location is a national
24	cemetery.

- "(C) When transportation of the remains in-1 2 cludes transportation by aircraft under section 562 of the John Warner National Defense Authorization 3 4 Act for Fiscal Year 2007 (Public Law 109–364; 10 5 U.S.C. 1482 note), the Secretary concerned shall 6 provide, to the maximum extent practicable, for de-7 livery of the remains by air to the commercial, gen-8 eral aviation, or military airport nearest to the place 9 selected by the designee.". (b) Conforming Amendment.—Section 562(d) of 10 the John Warner National Defense Authorization Act for 12 Fiscal Year 2007 (Public Law 109–364; 10 U.S.C. 1482) note) is amended— 13 14 (1) in paragraph (1), by striking "Except as 15 provided in paragraph (2)" and inserting "Subject 16 to paragraphs (2) and (3)"; and 17 (2) by adding at the end the following new 18 paragraph: 19 "(3) SECOND LOCATION.—If the person des-
- ignated to direct disposition of the remains selects two locations under section 1482(a)(8)(B) of title 10, United States Code, the Secretary concerned shall ensure that remains transported under this section are continuously escorted from Dover Air Force Base to the first selected location and from

1	the first selected location to the selected national
2	cemetery for final disposition. The Secretary con-
3	cerned is not required to provide an escort under
4	this paragraph during the period between the arrival
5	of the remains at the first location and the depar-
6	ture of the remains from that first location to the
7	selected national cemetery.".
8	SEC. 5. EXPANSION OF AUTHORITY TO PROVIDE FINANCIAL
9	ASSISTANCE TO CIVILIAN PROVIDERS OF
10	CHILD CARE SERVICES OR YOUTH PROGRAM
11	SERVICES WHO PROVIDE SUCH SERVICES TO
12	SURVIVORS OF MEMBERS OF THE ARMED
13	FORCES WHO DIE IN LINE OF DUTY.
14	Section 1798(a) of title 10, United States Code, is
15	amended by inserting ", survivors of members of the
16	armed forces who die in line of duty while on active duty,
17	active duty for training, or inactive duty for training,"
18	after "armed forces".
19	SEC. 6. CONTINUED ELIGIBILITY FOR DEPENDENCY AND
20	INDEMNITY COMPENSATION FOR SURVIVING
21	SPOUSES WHO REMARRY.
22	(a) In General.—Section 103(d) of title 38, United
23	States Code, is amended—
24	(1) in paragraph (2)(B), by adding at the end
25	the following: "Subject to sections 1450(c) and

1	1451(c)(2) of title 10, the remarriage of a surviving
2	spouse shall not bar the furnishing of benefits under
3	section 1311 of this title to the surviving spouse of
4	a veteran."; and
5	(2) in paragraph (5), by striking subparagraph
6	(A) and renumbering subparagraphs (B), (C), and
7	(D) as subparagraphs (A), (B), and (C), respec-
8	tively.
9	(b) RESUMPTION OF PAYMENTS TO CERTAIN INDI-
10	VIDUALS PREVIOUSLY DENIED DEPENDENCY AND IN-
11	DEMNITY COMPENSATION.—Beginning on the first day of
12	the first month after the date of the enactment of this
13	Act, the Secretary shall resume payment of dependency
14	and indemnity compensation under section 1311 of such
15	title to each living individual who—
16	(1) is the surviving spouse of a veteran; and
17	(2) remarried before—
18	(A) reaching age 57; and
19	(B) the date of the enactment of this Act.
