- 3 (A) IN THIS SECTION, "CONTROLLED WATER SKI AREA" MEANS AN AREA 4 THAT:
- 5 (1) IS MARKED BY THE DEPARTMENT;
- 6 (2) ENCOMPASSES A SKI SLALOM COURSE THAT IS PERMITTED BY 7 THE U.S. ARMY CORPS OF ENGINEERS; AND
- 8 (3) IS DESIGNED, CONSTRUCTED, AND INTENDED FOR CONTROLLED 9 WATER SKI PRACTICE.
- 10 (B) THIS SECTION APPLIES TO A CONTROLLED WATER SKI AREA LOCATED 11 IN MAYNADIER CREEK.
- 12 (C) A PERSON MAY NOT OPERATE OR GIVE PERMISSION TO OPERATE A
 13 VESSEL FOR THE PURPOSE OF TOWING A WATER SKIER IN A SKI SLALOM COURSE
 14 LOCATED IN A CONTROLLED WATER SKI AREA ON:
- 15 (1) SATURDAYS, SUNDAYS, AND STATE HOLIDAYS; AND
- 16 (2) Mondays, Tuesdays, Wednesdays, and Thursdays before 17 Noon and after 8:30 p.m.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2017.
