A BILL

- To reduce illegal wildlife trafficking and importation by extending State Department reporting on foreign wildlife trafficking activity, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Protecting All Wildlife

5 Against Trafficking Act" or the "PAW Against Traf-

6 ficking Act".

7 SEC. 2. FINDINGS.

8 Congress makes the following findings:

1	(1) Wildlife and plants, and endangered species
2	in particular, are threatened by illegal trafficking ac-
3	tivities around the world.
4	(2) Preserving endangered wildlife is critical to
5	maintaining a diverse global ecosystem.
6	(3) Illegal wildlife trafficking magnifies the
7	harm to our environment caused by pollution, defor-
8	estation, and other human activity.
9	(4) The State Department can play a critical
10	role in increasing awareness by travelers about ille-
11	gal wildlife trafficking activity, and can in turn re-
12	duce illicit importation of endangered, threatened, or
13	otherwise illegal wildlife products.
14	(5) Reporting on wildlife trafficking by the
15	State Department, and strategy and coordination ac-
16	tivities by the Presidential Task Force on Wildlife
17	Trafficking should be extended to ensure that the
18	United States remains a leader on wildlife conserva-
19	tion into the future.

1SEC. 3. PERMANENT EXTENSION OF ANNUAL STATE DE-2PARTMENT REPORTING ON INTERNATIONAL3WILDLIFE TRAFFICKING AND INCREASING4PUBLIC AWARENESS OF SUCH REPORTING.

5 (a) Section 201 of the Eliminate, Neutralize, and
6 Disrupt Wildlife Trafficking Act (16 U.S.C. 7621) is
7 amended by—

8 (1) striking subsection (c); and

9 (2) inserting at the end the following:

10 "(c) WEBSITE.—On any State Department website or web-based application providing country-specific infor-11 mation for international travel, the Secretary of State 12 13 shall ensure that any country listed as a focus country or a country of concern in the most recent publication of 14 the annual report required by section 201 of the Elimi-15 16 nate, Neutralize, and Disrupt Wildlife Trafficking Act (16) U.S.C. 7621) is clearly identified with a color-highlighted 17 18 warning label.

19 "(d) WARNING LABEL.—Any focus country or country of concern label displayed pursuant to subsection (c) 20 21 shall be accompanied by a warning that international law 22 or U.S. law may prohibit the export, import, purchase, 23 sale, possession, or transport of products produced from 24 endangered or threatened wildlife. The Secretary of State shall determine the appropriate nature of the warning to 25 be displayed pursuant to this subsection.". 26
