16	act may be cited as the "Omnibus Kenilworth Courts Redevelopment Act of 2020".
17	Sec. 2. (a) Pursuant to section 404 of the District of Columbia Home Rule Act, approved
18	December 24, 1973 (87 Stat. 787; D.C. Official Code § 1-204.04), and consistent with the Street
19	and Alley Closing and Acquisition Procedures Act of 1982, effective March 10, 1983 (D.C. Law
20	4-201; D.C. Official Code § 9-201.01 et seq.) (the "Act"), the Council of the District of
21	Columbia finds that the public alley in Square 5116, as shown on the Surveyor' plat filed in S.O.
22	16-23580, is unnecessary for alley purposes and orders it closed, with title to the land to vest as
23	shown on the Surveyor's plat.

30	Sec. 3. The ordering of the alley closing, acceptance of the street dedication and removal
31	of building restriction lines stated section 2 are contingent upon the satisfaction of all of the
32	conditions proposed by the District Department of Transportation and Washington Gas as set
33	forth in S.O. 16-23580.
34	Sec. 4. Fiscal impact statement.
