A BILL

To require the Director of the Office of Management and Budget to immediately release certain grant funds awarded for mitigation activities under the Community Development Block Grant program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Bipartisan Disaster
5 Recovery Funding Act of 2019”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) Funding for mitigation activities was appro-
4 priated to the Department of Housing and Urban
5 Development by Congress in February 2018 under
6 the Bipartisan Budget Act of 2018 (Public Law
7 115–123; 132 Stat. 64).

8 (2) The Secretary of Housing and Urban Devel-
9 opment told Congress that the funding described in
10 paragraph (1) would be released by May 1, 2019.

11 (3) May 1, 2019, has come and gone with no
12 official explanation as to the reason for the contin-
13 ued delay in releasing the funds.

14 **SEC. 3. REQUIREMENT.**

15 For all amounts made available for mitigation activi-
16 ties under the heading “Department of Housing and
17 Urban Development—Community Planning and Develop-
18 ment—Community Development Fund” in Public Law
19 115–123, and awarded as grants by the Secretary of
20 Housing and Urban Development, the Director of the Of-
21 fice of Management and Budget shall, not later than 60
22 days after the date of enactment of this Act, release such
23 amounts awarded to all eligible grantees, regardless of any
24 further studies as may be otherwise required by law.
