A BILL

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Bipartisan Disaster
- 5 Recovery Funding Act of 2019".

- (1) Funding for mitigation activities was appropriated to the Department of Housing and Urban Development by Congress in February 2018 under the Bipartisan Budget Act of 2018 (Public Law
- 8 (2) The Secretary of Housing and Urban Devel-9 opment told Congress that the funding described in 10 paragraph (1) would be released by May 1, 2019.
- 11 (3) May 1, 2019, has come and gone with no 12 official explanation as to the reason for the contin-13 ued delay in releasing the funds.

14 SEC. 3. REQUIREMENT.

- For all amounts made available for mitigation activi-
- 16 ties under the heading "Department of Housing and
- 17 Urban Development—Community Planning and Develop-
- 18 ment—Community Development Fund" in Public Law
- 19 115-123, and awarded as grants by the Secretary of
- 20 Housing and Urban Development, the Director of the Of-
- 21 fice of Management and Budget shall, not later than 60
- 22 days after the date of enactment of this Act, release such
- 23 amounts awarded to all eligible grantees, regardless of any
- 24 further studies as may be otherwise required by law.
