16 (b) Under the agreement, the [Division of Library Development and Services] 17 STATE LIBRARY AGENCY shall provide eligible blind and disabled individuals with access 18 to newspapers in a computerized audio format by a qualified entity.

19 SECTION 2. AND BE IT FURTHER ENACTED, That:

(a) The duties and responsibilities of the Division of Library Development and
Services in the State Department of Education shall be transferred to the State Library
Agency and the State Library Board on July 1, 2017.

(b) (1) All appropriations for fiscal year 2018, including State and federal
funds, held by the Division of Library Development and Services in the State Department
of Education to carry out the duties and responsibilities transferred under this Act shall be
transferred to the State Library Agency and the State Library Board on and after July 1,
2017.

(2) Funding for the services and programs under the State Library Agency
and the State Library Board shall be provided for in the fiscal 2019 State budget.

30 (c) On July 1, 2017, all of the functions, powers, duties, books and records 31 (including electronic records), real and personal property, equipment, fixtures, assets, 32 liabilities, obligations, credits, rights, and privileges of the Division of Library Development 33 and Services that are transferred under this Act shall be transferred to the State Library 34 Agency and the State Library Board.

1 SECTION 3. AND BE IT FURTHER ENACTED, That, as of July 1, 2017, the 2 Division of Library Development and Services is hereby abolished and the State Library 3 Agency and the State Library Board shall be the successor of the Division.

4 SECTION 4. AND BE IT FURTHER ENACTED, That all employees who are 5 transferred to the State Library Agency and the State Library Board as a result of this Act 6 shall be transferred without diminution of their rights, benefits, employment, or retirement 7 status.

8 SECTION 5. AND BE IT FURTHER ENACTED, That, except as expressly provided 9 to the contrary in this Act, any transaction affected by or flowing from any statute added, 10 amended, repealed, or transferred under this Act and validly entered into before the 11 effective date of this Act, and every right, duty, or interest flowing from it remains valid 12 after the effective date of this Act and may be terminated, completed, consummated, or 13 enforced under the law.

14SECTION 6. AND BE IT FURTHER ENACTED, That, except as otherwise provided 15by law, all existing laws, regulations, proposed regulations, standards and guidelines, 16 policies, orders and other directives, forms, plans, memberships, contracts, property, investigations, administrative and judicial responsibilities, rights to sue and be sued, and 17all other duties and responsibilities associated with the functions of the agencies and units 18 19that are the subject of this Act prior to the effective date of this Act shall continue in effect 20under and, as appropriate, are legal and binding on the State Library Agency and the State 21Library Board until completed, withdrawn, canceled, modified, or otherwise changed under 22the law.

SECTION 7. AND BE IT FURTHER ENACTED, That the State Library Board shall be the successor to the Maryland Advisory Council on Libraries and nothing in this Act shall affect the terms of office of a member of the Maryland Advisory Council on Libraries who is serving on the effective date of this Act. An individual who is a member of any such entity on the effective date of this Act shall remain a member for the balance of the term to which the member is appointed, unless the member sooner dies, resigns, or is removed under appropriate provisions of law.

30 SECTION 8. AND BE IT FURTHER ENACTED, That the publisher of the 31 Annotated Code of Maryland, in consultation with and subject to the approval of the 32 Department of Legislative Services, shall correct, with no further action required by the 33 General Assembly, cross-references and terminology rendered incorrect by this Act or by 34 any other Act of the General Assembly of 2017 that affects provisions enacted by this Act. 35 The publisher shall adequately describe any such correction in an editor's note following 36 the section affected.

37 SECTION 9. AND BE IT FURTHER ENACTED, That, if any provision of this Act or 38 the application thereof to any person or circumstance is held invalid for any reason in a 39 court of competent jurisdiction, the invalidity does not affect other provisions or any other 40 application of this Act that can be given effect without the invalid provision or application, 41 and for this purpose the provisions of this Act are declared severable. 1 SECTION 10. AND BE IT FURTHER ENACTED, That this Act shall take effect 2 July 1, 2017.
