## A BILL

To ensure the ballistic missile defense capacity of the Army.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Patriot Inventory Pro-
- 5 tection Act".
- 6 SEC. 2. PRESERVATION OF THE BALLISTIC MISSILE DE-
- 7 FENSE CAPACITY OF THE ARMY.
- 8 (a) Limitation.—None of the funds authorized to
- 9 be appropriated or otherwise made available for fiscal year
- 10 2018 or any fiscal year thereafter for the Army may be
- 11 obligated or expended to demilitarize any GEM-T inter-

- 1 ceptor or remove any such interceptor from the oper-
- 2 ational inventory of the Army until the date on which the
- 3 Secretary of the Army submits to the congressional de-
- 4 fense committees the evaluation conducted under sub-
- 5 section (b).
- 6 (b) EVALUATION.—The Secretary and the Chief of
- 7 Staff of the Army shall jointly conduct an evaluation of
- 8 the ability of the Army to meet warfighter requirements
- 9 and operational needs if GEM-T interceptors are removed
- 10 from the operational inventory of the Army. In conducting
- 11 such evaluation, the Secretary and the Chief of Staff shall
- 12 evaluate whether the Army can maintain an inventory of
- 13 interceptors necessary to retain the capability provided by
- 14 GEM-T interceptors and to meet such operational needs
- 15 by either—
- 16 (1) recertifying GEM-T interceptors (either
- 17 with or without modification); or
- 18 (2) developing, testing, and fielding a new low-
- 19 cost interceptor that can be placed on the oper-
- ational inventory of the Army prior to the retirement
- 21 of GEM-T interceptors.
- (c) Exception.—The limitation in subsection (a)
- 23 shall not apply to activities that the Secretary determines
- 24 are critical to the safety of GEM-T interceptors.
- 25 (d) Definitions.—In this section:

1	(1) The term "congressional defense commit-
2	tees" has the meaning given that term in section
3	101(a)(16) of title 10, United States Code.
4	(2) The term "GEM-T interceptor" means the
5	Patriot guidance enhanced missile TBM.
