A BILL

To amend the Congressional Budget Act of 1974 to subject certain direct spending programs to annual appropriations, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Mandatory Spending
- 5 Control and Accountability Act".

1	SEC. 2. ANNUAL APPROPRIATIONS REQUIRED FOR DIRECT
2	SPENDING PROGRAMS.
3	(a) In General.—Title III of the Congressional
4	Budget Act of 1974 (2 U.S.C. 632 et seq.) is amended
5	by adding after section 315 the following:
6	"ANNUAL APPROPRIATIONS REQUIRED FOR DIRECT
7	SPENDING PROGRAMS
8	"Sec. 316. (a) Notwithstanding any other provision
9	of law, in fiscal year 2021 and each fiscal year there-
10	after—
11	"(1) each direct spending program shall be subject
12	to annual discretionary appropriations; and
13	"(2) no funds may be obligated for any such program
14	using any amounts other than amounts provided in ad-
15	vance in appropriations Acts.
16	"(b) In this section, the term 'direct spending pro-
17	gram'—
18	"(1) means—
19	"(A) any program with respect to which
20	budget authority is provided (before the date of
21	enactment of this section) by law other than ap-
22	propriation Acts;
23	"(B) any program that is funded (before
24	the date of enactment of this section) through
25	entitlement authority; and

1	"(C) the Supplemental Nutrition Assist-
2	ance Program; and
3	"(2) does not include—
4	"(A) the old-age and survivors insurance
5	program established under title II of the Social
6	Security Act (42 U.S.C. 401 et seq.), but not
7	including disability insurance benefits under
8	section 223 of such Act (42 U.S.C. 423);
9	"(B) Medicare programs;
10	"(C) all programs administered by the De-
11	partment of Veterans Affairs; and
12	"(D) the TRICARE program (as defined
13	in section 1072 of title 10, United States
14	Code).".
15	(b) CLERICAL AMENDMENT.—The table of contents
16	of such Act is amended by inserting after the item relating
17	to section 316 the following new item:
	"Sec. 316. Annual appropriations required for direct spending programs.".
18	(c) President's Budget Submission.—Section
19	1105(a) of title 31, United States Code, is amended by
20	adding at the end the following:
21	"(40) such information as is necessary for the
22	making of accurate appropriations for direct spend-
23	ing programs subject to the appropriations process,
24	and recommendations on legislative changes to bring

- 1 spending on such programs to a sustainable basis, if
- 2 applicable.".
- 3 (d) Rules Committee Recommendations.—Not
- 4 later than 180 days after the date of enactment of this
- 5 Act, the Committee on Rules of the House of Representa-
- 6 tives shall submit to the House conforming amendments
- 7 to the Rules of the House of Representatives to effectuate
- 8 this title, including the requirement that the authority to
- 9 appropriate funds for direct spending programs subject to
- 10 the appropriations process is with the Committee on Ap-
- 11 propriations.
