4 FOR the purpose of altering a certain definition to repeal the exclusion of motor vehicle  $\mathbf{5}$ rental companies as owners of motor vehicles for the purpose of the enforcement of 6 violations of overtaking and passing school vehicles operating alternately flashing 7 red lights that are recorded by school bus monitoring cameras; requiring a law 8 enforcement agency to provide a certain notice to a motor vehicle rental company 9 before issuing a certain citation; prohibiting a law enforcement agency from mailing 10 a motor vehicle rental company a certain citation if the motor vehicle rental company 11 provides the law enforcement agency with certain information or pays a certain penalty; making conforming changes; and generally relating to vehicle rental 12 13companies and school bus monitoring cameras.

(iii) A citation issued under subparagraph (ii) of this paragraph shall
be mailed no later than 2 weeks after receipt of the evidence from the District Court.
