RELATING TO THE APPROPRIATION TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PRO GRAM'S DIVISION OF FACILITIES FOR FISCAL YEAR 2021; APPROPRIATING MON EYS TO THE PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM'S DIVISION OF FA CILITIES FOR FISCAL YEAR 2021; PROVIDING THE NECESSARY FUNDS FOR THE
 BOND LEVY EQUALIZATION PROGRAM; SPECIFYING THE AMOUNT OF REVENUE DIS TRIBUTED TO THE GENERAL FUND FOR FISCAL YEAR 2021; AND MAKING A TRANSFER
 TO THE PUBLIC SCHOOL INCOME FUND FOR FISCAL YEAR 2021.

9 Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Public Schools Educational Support Program's Division of Facilities the following amounts to be expended from the listed funds for the period July 1, 2020, through June 30, 2021:

SECTION 2. TRANSFER. Of the moneys appropriated to the Public Schools 19 Educational Support Program's Division of Facilities, the amount necessary 20 to fund the provisions of Section 33-906, Idaho Code, is hereby transferred 21 22 and appropriated to the Bond Levy Equalization Fund. If the funding appropriated in Section 1 of this act is insufficient to meet the requirements of 23 Section 33-906, Idaho Code, the difference shall be withdrawn and paid from 24 the Public Education Stabilization Fund, notwithstanding any other provi-25 sion of law to the contrary. 26

SECTION 3. DISTRIBUTION TO THE GENERAL FUND. Notwithstanding the
provisions of Section 63-2520(b)(4), Idaho Code, the amount of revenue distributed to the General Fund shall be \$8,796,600 for the period July 1, 2020,
through June 30, 2021.

SECTION 4. TRANSFER FOR PUBLIC SCHOOLS EDUCATIONAL SUPPORT PROGRAM. Of the moneys appropriated in Section 1 of this act, there is hereby appropriated and the State Controller shall transfer \$12,344,800 from the General Fund to the Public School Income Fund to be expended for the Public Schools Educational Support Program's Division of Facilities for the period July 1, 2020, through June 30, 2021.
