## RESOLUTION

Of inquiry requesting the President and directing the Attorney General to transmit, respectively, certain documents to the House of Representatives relating to the removal

of former Federal Bureau of Investigation Director James Comey.

1       *Resolved*, That the President is requested, and Attor-  
 2       ney General of the United States is directed, to transmit,  
 3       respectively (in a manner appropriate to classified infor-  
 4       mation, if the President or Attorney General determines  
 5       appropriate), to the House of Representatives, not later  
 6       than 14 days after the date of the adoption of this resolu-  
 7       tion, copies of any document, record, audio recording,  
 8       memo, correspondence, or other communication in their  
 9       possessions, or any portion of any such communication,  
 10      that refers or relates to the following:

11               (1) The firing of Director James B. Comey of  
 12      the Federal Bureau of Investigation.

13               (2) The participation of Attorney General Jef-  
 14      ferson Sessions in the removal of Director Comey.

15               (3) The scope or application of Attorney Gen-  
 16      eral Sessions' recusal from "any existing or future  
 17      investigations of any matters in any way related to  
 18      the campaigns for President of the United States".

19               (4) The application of Attorney General Ses-  
 20      sions' recusal to the removal of Director Comey.

21               (5) The scope or application of executive privi-  
 22      lege as applied to the June 13, 2017, testimony of  
 23      Attorney General Sessions before the Senate Select  
 24      Committee on Intelligence.

1           (6) President Donald J. Trump's statement,  
2           communicated via Twitter on May 12, 2017, at 8:26  
3           a.m.: "James Comey better hope that there are no  
4           'tapes' of our conversations before he starts leaking  
5           to the press!"

6           (7) Any system used by the White House to se-  
7           cretly record conversations between President  
8           Trump and Director Comey.

9           (8) Any contemporaneous account of any meet-  
10          ing between President Trump and Director Comey.

11          (9) Any communication Donald Trump, Jr.,  
12          Paul Manafort, or Jared Kushner may have had  
13          with the Department of Justice or the Federal Bu-  
14          reau of Investigation that relates to their June 9,  
15          2016, meeting with Natalia Veselnitskaya, Rinat  
16          Akhmetshin, and Irakly Kaveladze.

17          (10) Any analysis regarding the violation of any  
18          criminal law with respect to that June 9, 2016,  
19          meeting, including any analysis of the Federal Elec-  
20          tion Campaign Act of 1971, the Computer Fraud  
21          and Abuse Act, or the Espionage Act of 1917 as it  
22          may pertain to a Federal campaign's attempt to ob-  
23          tain information that "would incriminate Hillary"  
24          from a foreign government.

20           *(3) The scope or application of Attorney General*

 22           *tigations of any matters in any way related to the*  
 23           *campaigns for President of the United States".*

24           *(4) The application of Attorney General Ses-*  
 25           *sions' recusal to the removal of Director Comey.*

3           *torney General Sessions before the Senate Select Com-*

21          (10) *Any analysis regarding the violation of any*  
22          *criminal law with respect to that June 9, 2016, meet-*  
23          *ing, including any analysis of the Federal Election*  
24          *Campaign Act of 1971, the Computer Fraud and*  
25          *Abuse Act, or the Espionage Act of 1917 as it may*

1        *pertain to a Federal campaign's attempt to obtain in-*  
2        *formation that "would incriminate Hillary" from a*  
3        *foreign government.*

4                *(11) The disposition or review of any applica-*  
5        *tion for a security clearance submitted by White*  
6        *House advisor Jared Kushner or Attorney General*  
7        *Sessions.*
