CHAPTER _____

1 AN ACT concerning

2 **State Government – Display of the POW/MIA Flag on State Building Grounds**

3 FOR the purpose of requiring the Secretary of General Services and the Secretary of
4 Transportation to cause the POW/MIA flag to be flown on the grounds of certain
5 State buildings whenever the flag of the United States is flown; providing for the
6 application of a certain provision of this Act; defining a certain term; and generally
7 relating to the display of the POW/MIA flag on the grounds of State buildings.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
14 That the Laws of Maryland read as follows:

15 **Article – State Finance and Procurement**

16 **4–210.**

(A) IN THIS SECTION, "POW/MIA FLAG" MEANS THE POW/MIA FLAG OF THE NATIONAL LEAGUE OF FAMILIES OF AMERICAN PRISONERS AND MISSING IN SOUTHEAST ASIA.

(B) THIS SECTION DOES NOT APPLY TO:

(1) THE STATE HOUSE; OR

(2) A STATE BUILDING THAT:

(I) IS A HISTORIC BUILDING; OR

(II) 1. HAS A FLAGPOLE ATTACHED TO THE BUILDING; AND

2. IS DETERMINED TO BE STRUCTURALLY UNABLE TO WITHSTAND ADDITIONAL FLAGS BEING FLOWN FROM THE FLAGPOLE.

(C) THE SECRETARY OF GENERAL SERVICES AND THE SECRETARY OF TRANSPORTATION SHALL CAUSE THE POW/MIA FLAG TO BE FLOWN ON THE GROUNDS OF ALL STATE BUILDINGS UNDER THEIR CONTROL WHENEVER THE FLAG OF THE UNITED STATES IS FLOWN.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2017.
