HOUSE SUBSTITUTE TO SENATE RESOLUTION 204

A RESOLUTION

1 Dedicating certain portions of the state highway system; and for other purposes.

PART I

- 3 WHEREAS, our nation's security continues to rely on patriotic men and women who put
- 4 their personal lives on hold in order to place themselves in harm's way to protect the
- 5 freedoms that all United States citizens cherish; and
- 6 WHEREAS, Mr. Kyle Gilbert demonstrated a deep personal commitment to protecting
- 7 democracy and a willingness to sacrifice his own personal safety and comfort to ensure the
- 8 well-being of his fellow man; and
- 9 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United
- 10 States Army, valiantly and courageously protecting his fellow Americans, and was killed in
- 11 Afghanistan; and
- 12 WHEREAS, a graduate of Mill Creek High School, Mr. Gilbert was a junior leader of his
- 13 battalion and his commendations included the Army Commendation Medal, the Army
- 14 Achievement Medal, the National Defense Service Medal, the Global War on Terrorism
- 15 Service Medal, the Afghanistan Campaign Medal, and the Army Service Ribbon; and
- 16 WHEREAS, Mr. Gilbert was a person of magnanimous strengths with an unimpeachable
- 17 reputation for integrity, intelligence, fairness, and kindness, and by the example he made of
- 18 his life, he made this world a better place in which to live; and
- 19 WHEREAS, a compassionate and generous man, Mr. Gilbert will long be remembered for
- 20 his love of family and friendship, and this loyal son, brother, and friend will be missed by all
- 21 who had the great fortune of knowing him; and

22 WHEREAS, Mr. Gilbert embodied the spirit of service, willing to find meaning in something

- 23 greater than himself, and it is abundantly fitting and proper that this remarkable and
- 24 distinguished American be recognized appropriately by dedicating a highway in his memory.

25 PART II

- 26 WHEREAS, the State of Georgia lost one of its finest citizens and civil rights activists on
- 27 August 15, 2015, with the passing of Mr. Horace Julian Bond; and
- 28 WHEREAS, Mr. Bond was born in Nashville, Tennessee, and raised in Pennsylvania while
- 29 his father served as the first African American president of Lincoln University; and
- 30 WHEREAS, he attended Morehouse College in Atlanta, where he helped found *The Pegasus*,
- 31 a literary magazine, and worked as an intern at *TIME* magazine; and
- 32 WHEREAS, during his time at Morehouse College, Mr. Bond was a founding member of the
- 33 Committee on Appeal for Human Rights, led nonviolent student protests against segregation
- 34 in Atlanta parks, restaurants, and movie theaters, and helped form the Student Nonviolent
- 35 Coordinating Committee in Raleigh, North Carolina; and
- 36 WHEREAS, Mr. Bond was voted into the Georgia House of Representatives in 1965 but
- 37 could not take his seat until court ordered action in 1967 because the legislature refused to
- 38 swear him in due to his vocal opposition to the Vietnam War; and
- 39 WHEREAS, he served in the House of Representatives until 1975 and went on to serve in
- 40 the Georgia Senate from 1975 to 1986, sponsoring more than 60 bills that were ratified into
- 41 law during his tenure with the General Assembly; and
- 42 WHEREAS, Mr. Bond served as president of the Southern Poverty Law Center from 1971
- 43 to 1979 and was an active member of the National Association for the Advancement of
- 44 Colored People from 1998 to 2010; and
- 45 WHEREAS, he served as a commentator for NBC's "Today" show, wrote a national
- 46 newspaper column, and produced poems that have appeared in publications such as the
- 47 Nation and the New York Times; and
- 48 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 49 Georgian be recognized appropriately by dedicating a road in his honor.

- 51 WHEREAS, Samuel L. and LaTanya Jackson have long been recognized for their talent on
- stage and ability to bring joy and delight to audiences; and
- 53 WHEREAS, a native of Atlanta, Georgia, LaTanya Richardson Jackson was a student at
- 54 Spelman College when she met her husband, Samuel, while he was attending Morehouse
- 55 College; and
- 56 WHEREAS, Samuel has appeared in more than 100 films and is one of Hollywood's most
- 57 respected actors, with an incredible career spanning five decades; and
- 58 WHEREAS, he is cool like Fonzie, starring as Jules, the philosopher hit man, in the cult
- 59 classic *Pulp Fiction* and appearing in numerous other Quentin Tarantino films, including *The*
- 60 Hateful Eight, Kill Bill, and Django Unchained; and
- 61 WHEREAS, his depth as an actor can be further demonstrated by his wide-ranging roles in
- 62 movies such as Jackie Brown, Jurassic Park, The Long Kiss Goodnight, A Time to Kill, The
- 63 Incredibles, Do the Right Thing, Snakes on a Plane, and the Avengers and Star Wars series;
- 64 and
- 65 WHEREAS, a standout actress in her own right, LaTanya starred in the 2003 musical *The*
- 66 Fighting Temptations and was nominated for a Tony Award for Best Lead Actress in a Play
- 67 for her role in the 2013 performance of A Raisin in the Sun; and
- 68 WHEREAS, they are blessed with one remarkable daughter, Zoe Jackson, who is a freelance
- 69 film and television producer; and
- 70 WHEREAS, it is abundantly fitting and proper that the members of this body recognize the
- 71 lives and careers of these distinguished individuals by dedicating a road in their honor.

- 73 WHEREAS, the Berrong family of Towns County, Georgia, has a rich history and tradition
- of service to the community; and
- 75 WHEREAS, Mr. Jay Berrong served as a guardian of this nation's freedom and liberty with
- 76 the United States military during World War II and was captured as a prisoner of war; and

77 WHEREAS, several members of the Berrong family sacrificed their own safety and comfort

- 78 to protect and serve this nation in the military; and
- 79 WHEREAS, Mr. Kris Berrong continues his family's tradition of service as a member of the
- 80 Hiawassee City Council; and
- 81 WHEREAS, Mr. Sanford Berrong ran the town store in High Tower while the Titus post
- 82 office was operated by Mr. Homer Berrong; and
- WHEREAS, generations of the Berrong family have lived their entire lives near the bridge
- 84 on SR 2/US 76 near Clayton Mountain Road; and
- 85 WHEREAS, some of Towns County's first educators were members of the Berrong family
- 86 while Mr. Darren Berrong serves as the current superintendent for Towns County high
- 87 schools; and
- 88 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 89 Georgia family be recognized appropriately by dedicating a bridge in their honor.

- 91 WHEREAS, Mr. Tyler Perry was born on September 13, 1969, in New Orleans, Louisiana;
- 92 and
- 93 WHEREAS, in 1998, his first musical, *I Know I've Been Changed*, premiered at the famous
- 94 Fox Theatre in Atlanta; in 2005, his first feature film, Diary Of A Mad Black Woman,
- 95 debuted at number one; and in 2006, he released his first book, *Don't Make A Black Woman*
- 96 Take Off Her Earrings: Madea's Uninhibited Commentaries On Life And Love, which
- 97 remained on the *New York Times* bestseller list for eight weeks; and
- 98 WHEREAS, in 2007, Mr. Perry's comedic talents delighted audiences worldwide with the
- 99 TBS series *House of Payne* and later with the series *Meet the Browns*, which were the highest
- and second highest rated first-run syndicated cable shows of all time, respectively, and he
- 101 currently has four television series on Oprah Winfrey's network, OWN; and
- 102 WHEREAS, in 2008, he revitalized Delta Airlines' former headquarters and opened a
- 103 200,000 square foot studio in Atlanta that employs hundreds of Georgians, and in 2015,
- 104 Mr. Perry bought 330 acres of the former military base, Fort McPherson, on which he will

restore and construct state-of-the-art facilities that will open the door for local business

- opportunities and job creation in the motion picture and television industry; and
- 107 WHEREAS, Mr. Perry strongly supports our state and national communities through
- 108 charities such as Feeding America, Covenant House, Hosea Feed the Hungry, Project
- 109 Adventure, Perry Place, and his own foundation, the Tyler Perry Foundation, which
- transforms tragedy into triumph by empowering economically disadvantaged youths, seniors,
- and families to overcome adversity by achieving a better quality of life; and
- 112 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- Georgian be recognized appropriately by dedicating a road in his honor.

- baseball player in American history; and

- 119 WHEREAS, the eldest of three children, he grew up in Royston, Georgia, under the watchful
- eyes of his father, who was a schoolteacher, principal, newspaper publisher, state senator,
- and county school commissioner; and
- 122 WHEREAS, in his 24 seasons of playing baseball, he broke .300 batting average an
- incredible 23 times; and
- 124 WHEREAS, he played a majority of his career with the Detroit Tigers, was a leader in runs
- scored with 2,245, and took the Tigers to the World Series in 1907; and
- 126 WHEREAS, Mr. Cobb was the Baseball Hall of Fame's first inductee in 1936; and
- 127 WHEREAS, a generous philanthropist, Mr. Cobb donated funding to build a 24 bed hospital
- in Royston and \$100,00.00 for college scholarships for needy students in Georgia through
- the Ty Cobb Educational Foundation; and
- 130 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished
- 131 Georgian be recognized appropriately by dedicating a road in his honor.

- 176 Baptist Church and was a Gideon who helped spread the Word of God by distributing
- 177 Gideon Bibles; and
- 178 WHEREAS, he diligently and conscientiously devoted his time, talents, and energy as a
- 179 member of the Masonic Lodge; and
- 180 WHEREAS, it is abundantly fitting and proper that this remarkable and distinguished

- 184 School System in 1969 and assigned to East Ochlocknee School where he served as teacher
- and acting principal; and
