## A BILL

To redesignate the Weir Farm National Historic Site in  
the State of Connecticut as the “Weir Farm National  
Historical Park”.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Weir Farm National  
5 Historical Park Redesignation Act”.

6 **SEC. 2. WEIR FARM NATIONAL HISTORICAL PARK.**

7 (a) IN GENERAL.—The Weir Farm National Historic  
8 Site shall be known and designated as the “Weir Farm  
9 National Historical Park”.

1 (b) AMENDMENTS TO THE WEIR FARM NATIONAL  
 2 HISTORIC SITE ESTABLISHMENT ACT OF 1990.—The  
 3 Weir Farm National Historic Site Establishment Act of  
 4 1990 (54 U.S.C. 320101 note; Public Law 101–485; 104  
 5 Stat. 1171; 108 Stat. 4756; 112 Stat. 3296; 123 Stat.  
 6 1190) is amended—

7 (1) in section 2(2)—

8 (A) by striking “historic site” and insert-  
 9 ing “historical park”; and

10 (B) by striking “National Historic Site”  
 11 and inserting “National Historical Park”;

12 (2) in section 4—

13 (A) in the heading, by striking “**HISTORIC**  
 14 **SITE**” and inserting “**HISTORICAL PARK**”;

15 (B) in subsection (a), by striking “Historic  
 16 Site” and inserting “Historical Park”; and

17 (C) by striking “historic site” each place it  
 18 appears and inserting “historical park”;

19 (3) in section 5, by striking “historic site” each  
 20 place it appears and inserting “historical park”; and

21 (4) in section 6—

22 (A) in the heading, by striking “**HISTORIC**  
 23 **SITE**” and inserting “**HISTORICAL PARK**”;

24 and

1 (B) by striking “historic site” each place it  
2 appears and inserting “historical park”.

3 (c) REFERENCES.—Any reference in any law, regula-  
4 tion, document, record, map, or other paper of the United  
5 States to the Weir Farm National Historic Site shall be  
6 considered to be a reference to the “Weir Farm National  
7 Historical Park”.
