A BILL

To require the Administrator of General Services to conduct an annual audit of properties leased to private parties, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "GSA Lease Trans-
- 5 parency Act of 2019".
- 6 SEC. 2. ANNUAL AUDIT.
- 7 (a) In General.—Chapter 5 of subtitle I of title 40,
- 8 United States Code, is amended by adding at the end the
- 9 following:

10 "§ 625. Annual audit of leases

- 11 "(a) IN GENERAL.—Not later than 90 days after the
- 12 date of enactment of this Act, and annually thereafter,
- 13 the Administrator of General Services shall complete an
- 14 audit, in compliance with generally accepted government
- 15 accounting standards, of covered leases.
- 16 "(b) Content of Audit.—The audit shall deter-
- 17 mine whether the Federal Government has received all
- 18 rent, revenues, and anything of value due in accordance
- 19 with the provisions of each covered lease.
- 20 "(c) Submission.—Not later than 30 days after the
- 21 date of completion of an audit, the Administrator of Gen-
- 22 eral Services shall submit to the Committee on Transpor-
- 23 tation and Infrastructure of the House of Representatives
- 24 and the Committee on Environment and Public Works of
- 25 the Senate the audit and a report on such audit.
