3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "National Instant
- 5 Criminal Background Check System (NICS) Data Integ-
- 6 rity Act of 2020".

7 SEC. 2. SEARCH OF NATIONAL DATA EXCHANGE.

8 (a) RETENTION OF BACKGROUND CHECK
9 RECORDS.—Section 103 of the Brady Handgun Violence
10 Prevention Act (34 U.S.C. 40901) is amended—

1	(1) by redesignating subsections (h) through (k)
2	as subsections (i) through (l) respectively; and
3	(2) by inserting after subsection (g) the fol-
4	lowing new subsection:
5	"(h) Record Retention.—
6	"(1) DEADLINE FOR RETENTION.—Notwith-
7	standing any other provision of law, the system may
8	retain records related to a transfer or potential
9	transfer of a firearm to a person who is the subject
10	of a call to the system pursuant to subsections (s)
11	or (t) of section 922 of title 18, United States Code,
12	for as long as necessary to determine whether re-
13	ceipt of a firearm by the person would violate sub-
14	sections (g) or (n) of such section or State law.
15	"(2) NOTICE OF RETENTION.—If the system
16	has not determined whether receipt of a firearm by
17	a person would violate subsections (g) or (n) of sec-
18	tion 922 of title 18, United States Code, or State
19	law within 30 days after a call to the system with
20	respect the person, the system shall notify the per-
21	son in writing (or by electronic mail if the person
22	has consented to the use of electronic mail) that—
23	"(A) the system may retain records relat-
24	ing to the person and the transfer of a firearm
25	until the system determines that receipt of such

1	firearm by the person does not violate sub-
2	sections (g) or (n) of section 922 of title 18,
3	United States Code, or State law; and
4	"(B) the person may submit to the Attor-
5	ney General information to correct, clarify, or
6	supplement records (with respect to the person)
7	retained by the system in accordance with this
8	section and any regulation established by the
9	Attorney General.".

11	tion 103(e)(1) of the Brady Handgun Violence Prevention
