Mr. REICHERT (for himself and Mr. PASCRELL) introduced the following bill;
which was referred to the Committee on Financial Services

A BILL

To require the Secretary of the Treasury to mint a coin in commemoration of the opening of the National Law Enforcement Museum in the District of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Law Enforce-
5 ment Museum Commemorative Coin Act”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds the following:

1 (1) In 2000, Congress passed and President
2 William J. Clinton signed into law the National Law
3 Enforcement Museum Act (Public Law 106–492),
4 which authorized the National Law Enforcement Of-
5 ficers Memorial Fund, Inc. to build the National
6 Law Enforcement Museum on Federal land in the
7 District of Columbia to honor and commemorate the
8 service and sacrifice of law enforcement officers in
9 the United States.

10 (2) In April 2016, construction began on the
11 National Law Enforcement Museum in the District
12 of Columbia across the street from the National Law
13 Enforcement Officers Memorial in Judiciary Square.

14 (3) The National Law Enforcement Museum
15 will formally open in September of 2018.

16 (4) The National Law Enforcement Museum’s
17 mission is—

18 (A) to honor and commemorate the ex-
19 traordinary service and sacrifice of America’s
20 law enforcement officers;

21 (B) to serve as an important bridge be-
22 tween law enforcement’s past and present, be-
23 tween the heroes of yesteryear and those who
24 have followed in their footsteps, and between

1 America's peace officers and the public they
2 serve; and

3 (C) increase public understanding and sup-
4 port for law enforcement and to promote law
5 enforcement safety.

6 **SEC. 3. COIN SPECIFICATIONS.**

7 (a) DENOMINATIONS.—The Secretary of the Treas-
8 ury (hereafter in this Act referred to as the “Secretary”)
9 shall mint and issue the following coin:

10 (1) \$5 GOLD COINS.—Not more than 50,000 \$5
11 coins, which shall—

12 (A) weigh 8.359 grams;

13 (B) have a diameter of 0.850 inches; and

14 (C) contain not less than 90 percent gold.

15 (2) \$1 SILVER COINS.—Not more than 400,000
16 \$1 coins, which shall—

17 (A) weigh 26.73 grams;

18 (B) have a diameter of 1.500 inches; and

19 (C) contain not less than 90 percent silver.

20 (3) HALF-DOLLAR CLAD COINS.—Not more
21 than 750,000 half-dollar coins which shall—

22 (A) weigh 11.34 grams;

23 (B) have a diameter of 1.205 inches; and

1 (C) be minted to the specifications for half-
2 dollar coins contained in section 5112(b) of title
3 31, United States Code.

4 (b) LEGAL TENDER.—The coins minted under this
5 Act shall be legal tender, as provided in section 5103 of
6 title 31, United States Code.

7 (c) NUMISMATIC ITEMS.—For purposes of section
8 5134 of title 31, United States Code, all coins minted
9 under this Act shall be considered to be numismatic items.

10 **SEC. 4. DESIGN OF COINS.**

11 (a) DESIGN REQUIREMENTS.—

12 (1) IN GENERAL.—The design of the coins
13 minted under this Act shall be emblematic of the
14 National Law Enforcement Museum and the service
15 and sacrifice of law enforcement officers throughout
16 the history of the United States.

17 (2) DESIGNATION AND INSCRIPTIONS.—On
18 each coin minted under this Act there shall be—

19 (A) a designation of the value of the coin;

20 (B) an inscription of the year “2021”; and

21 (C) inscriptions of the words “Liberty”,
22 “In God We Trust”, “United States of Amer-
23 ica”, and “E Pluribus Unum”.

24 (b) SELECTION.—The design for the coins minted
25 under this Act shall be—

1 (1) selected by the Secretary after consultation
2 with the Commission of Fine Arts and the National
3 Law Enforcement Officers Memorial Fund, Inc.; and
4 (2) reviewed by the Citizens Coinage Advisory
5 Committee.

6 **SEC. 5. ISSUANCE OF COINS.**

7 (a) **QUALITY OF COINS.**—Coins minted under this
8 Act shall be issued in uncirculated and proof qualities.

9 (b) **MINT FACILITIES.**—Only 1 facility of the United
10 States Mint may be used to strike any particular quality
11 of the coins minted under this Act.

12 (c) **PERIOD FOR ISSUANCE.**—The Secretary may
13 issue coins minted under this Act only during the 1-year
14 period beginning on January 1, 2021.

15 **SEC. 6. SALE OF COINS.**

16 (a) **SALE PRICE.**—The coins issued under this Act
17 shall be sold by the Secretary at a price equal to the sum
18 of—

19 (1) the face value of the coins;

20 (2) the surcharge provided in section 7(a) with
21 respect to such coins; and

22 (3) the cost of designing and issuing the coins
23 (including labor, materials, dies, use of machinery,
24 overhead expenses, marketing, and shipping).

1 (b) BULK SALES.—The Secretary shall make bulk
2 sales of the coins issued under this Act at a reasonable
3 discount.

4 (c) PREPAID ORDERS.—

5 (1) IN GENERAL.—The Secretary shall accept
6 prepaid orders for the coins minted under this Act
7 before the issuance of such coins.

8 (2) DISCOUNT.—Sale prices with respect to pre-
9 paid orders under paragraph (1) shall be at a rea-
10 sonable discount.

11 **SEC. 7. SURCHARGES.**

12 (a) IN GENERAL.—All sales of coins issued under this
13 Act shall include a surcharge of—

14 (1) \$35 per coin for the \$5 coin;

15 (2) \$10 per coin for the \$1 coin; and

16 (3) \$5 per coin for the half-dollar coin.

17 (b) DISTRIBUTION.—Subject to section 5134(f)(1) of
18 title 31, United States Code, all surcharges received by
19 the Secretary from the sale of coins issued under this Act
20 shall be promptly paid by the Secretary to the National
21 Law Enforcement Officers Memorial Fund, Inc. for edu-
22 cational and outreach programs and exhibits.

23 (c) AUDITS.—The National Law Enforcement Offi-
24 cers Memorial Fund, Inc., shall be subject to the audit
25 requirements of section 5134(f)(2) of title 31, United

1 States Code, with regard to the amounts received under
2 subsection (b).

3 (d) LIMITATION.—Notwithstanding subsection (a),
4 no surcharge may be included with respect to the issuance
5 under this Act of any coin during a calendar year if, as
6 of the time of such issuance, the issuance of such coin
7 would result in the number of commemorative coin pro-
8 grams issued during such year to exceed the annual 2
9 commemorative coin program issuance limitation under
10 section 5112(m)(1) of title 31, United States Code (as in
11 effect on the date of the enactment of this Act). The Sec-
12 retary of the Treasury may issue guidance to carry out
13 this subsection.
