A BILL

To require that certain standards for commercial driver's licenses applicable to former members of the armed services or reserves also apply to current members of the armed services or reserves.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Active Duty Voluntary*
 5 *Acquisition of Necessary Credentials for Employment Act”*
 6 *or the “ADVANCE Act”.*

7 **SEC. 2. COMMERCIAL DRIVER’S LICENSE STANDARDS FOR**
 8 **SERVICE MEMBERS AND VETERANS.**

9 *Section 31305(d) of title 49, United States Code, is*
 10 *amended—*

11 *(1) in the subsection heading, by striking “VET-*
 12 *ERAN OPERATORS” and inserting “SERVICE MEM-*
 13 *BERS, RESERVISTS, AND VETERANS”;*

14 *(2) in paragraph (1)(B), by striking “subpara-*
 15 *graph (A) during” and inserting “subparagraph*
 16 *(A)—*

17 *“(i) while serving in the armed forces*
 18 *or reserve components; and*

19 *“(ii) during”; and*

20 *(3) in paragraph (2)(B), by inserting “current*
 21 *or” before “former” each place the term appears.*
