
Pursuant to D.C. Official Code § 2-352.02, enclosed for consideration by the Council of the District of Columbia is proposed emergency legislation and bill entitled the "Modifications to Contract No. DCRL-2016-C-0113 with Total Healthcare Solutions, LLC Approval and Payment Authorization Emergency Act of 2017" and the accompanying declaration resolution. The proposed legislation is to approve proposed Modification No. 003 to contract No. DCRL-2016-C-0113 ("Contract"), and to approve payment for services received and to be received by the Child and Family Services Agency under the Contract.

Council approval is necessary because, when Child and Family Services Agency (CFSA) issues Modification 003 the total not-to-exceed amount for the contract will be in excess of one million dollars. Council approval is necessary because the proposed Modification 003 would increase the total not-to-exceed amount to a value that is in excess of one million dollars. The proposed modification will allow for Licensed Registered Nurse Practitioners, Certified Medical Assistants and Medical Records Technicians to provide medical services to District's children and youth removed from their homes due to abuse and/or neglect and to authorize payment for services to be received under this contract modification. The proposed total not-to-exceed amount for the base year is one million, three hundred seventeen, five hundred twenty-one dollars and four cents (\$1,317,521.04) for the period of performance from March 31, 2016 through March 30, 2017.

A RESOLUTION

IN THE COUNCIL OF THE DISTRICT OF COLUMBIA

To declare the existence of an emergency with respect to the need to approve proposed Modification 003 to Contract No. DCRL-2015-R-0113 with Total Healthcare Solutions, LLC. to provide Licensed Registered Nurse Practitioners, Certified Medical Assistants, and Medical Records Technicians to provide medical services to District's children and youth removed from their homes due to abuse and neglect and to authorize payment for services to be received under this contract.

RESOLVED, BY THE COUNCIL OF THE DISTRICT OF COLUMBIA, that this resolution may be cited as the "Modifications to Contract No. DCRL-2016-R-0113 with Total Healthcare Solution, LLC Approval and Payment Authorization Emergency Declaration Resolution of 2017".

Sec. 2. (a) There exists a need to approve proposed Modification 004 to Contract No. DCRL-2016-R-0113 with Total Healthcare Solution, LLC, to provide Licensed Registered Nurse Practitioners, Certified Medical Assistants and Medical Records Technicians to provide medical services to District' children and youth removed from their homes due to neglect and abuse and to authorize payment for services to be received under this proposed contract modification.

1 (b) By proposed Modification 003, CFSA proposes to increase the  
2 contract amount from \$998,602.56 to \$1,377,399.20, an increase of \$378,796.64.

3 (c) Council approval is necessary because this proposed Modification  
4 increases the total contract amount to more than \$1,000,000 during a 12-month period.

5 (d) Approval is necessary to allow the continuation of these vital services.  
6 Without this approval Total Healthcare Solutions, LLC, cannot be paid for services  
7 provided in excess of \$1,000,000.00.

8 Sec. 3. The Council determines that the circumstances enumerated in section 2  
9 constitute emergency circumstances making it necessary that the Modifications to  
10 Contract No. DCRL-2015-R-0113 with Total healthcare Solutions, LLC. Approval and  
11 Payment Authorization Emergency Act of 2017 be adopted after a single reading.

12 Sec. 4. This resolution shall take effect immediately.
